Attached please find a signed Statement of Designation of Counsel form authorizing Patrick Pace of the law firm of Kamuf, Pace & Kamuf in Owensboro, Kentucky and I to represent Owensboro Dermatology Associates in MUR 6270.

As we discussed earlier today, I am already representing Rand Paul for U.S. Senate, Dr. Rand Paul, Eric D. Stein, David Adams, the Committee to Re-Elect Ron Paul and Dr. Ron Paul in MUR 6270. Last Thursday, the Office of the General Counsel granted my request for a thirty-day extension of time in order to file responses to the complaint in MUR 6270 on behalf of those six respondents. Their responses are now due on Thursday, June 3, 2010.

Owensboro Dermatology Associates received a copy of the complaint in MUR 6270 on April 20, 2010. As you know, 11 C.F.R. 111.6(a) provides that a respondent may file a written response to the complaint within fifteen days of receiving it. Since Owensboro Dermatology Associates received the complaint on April 20, 2010, its response would be due on Wednesday, May 5, 2010.

Needless to say, although Mr. Pace and I have initiated an investigation into the allegations that have been made against Owensboro Dermatology Associates, there will not be enough time to prepare a written response by Wednesday. Accordingly, I hereby request an extension of time of twenty-nine (29) days until Thursday, June 3, 2010 in order to file a response on behalf of Owensboro Dermatology Associates. Granting such an extension would conserve Commission resources by having all such respondents in MUR 6270 file their responses on the same day.
