As a resident of Ohio's 16<sup>th</sup> Congressional district, I am hereby submitting this Complaint in response to several F.E.C. law violations by the Committee to Elect Matt Miller (Respondent).

**FACTS:**

1. Matt Miller is Republican candidate for Congress in Ohio's 16<sup>th</sup> congressional district.
2. Matt Miller has formed an official campaign committee, the Committee to Elect Matt Miller.
3. This is Matt Miller's third consecutive campaign for this congressional seat, he ran and lost in the 2006 and 2008 Republican primary.
4. Matt Miller's campaign is currently engaged in several forms of "public communications", as defined by 11 CFR 110.11(a).
  - a. The specific forms of communication that constitute the basis for this complaint are
    - i. Billboards
    - ii. Yard Signs
    - iii. Mail Pieces

**ALLEGATIONS:**

1. Respondent has failed to comply with 11 CFR 110.11(c)(2)(i), (ii) and (iii), by failing to print a disclaimer in a clearly defined box that is set apart from the other contents of the communication.
  - a. Proof of Respondent's failure to comply is evidence by the attached exhibits 1, 2 and 3.
2. Respondent has knowingly and willfully printed false materials on its campaign communications by listing a Don Eiserling as the committee's Treasurer. Don Eiserling has not been Treasurer since 7/13/07, at which time Matt Miller became Treasurer.
  - a. Proof of Respondent's violation is evidenced by the attached exhibit 2.

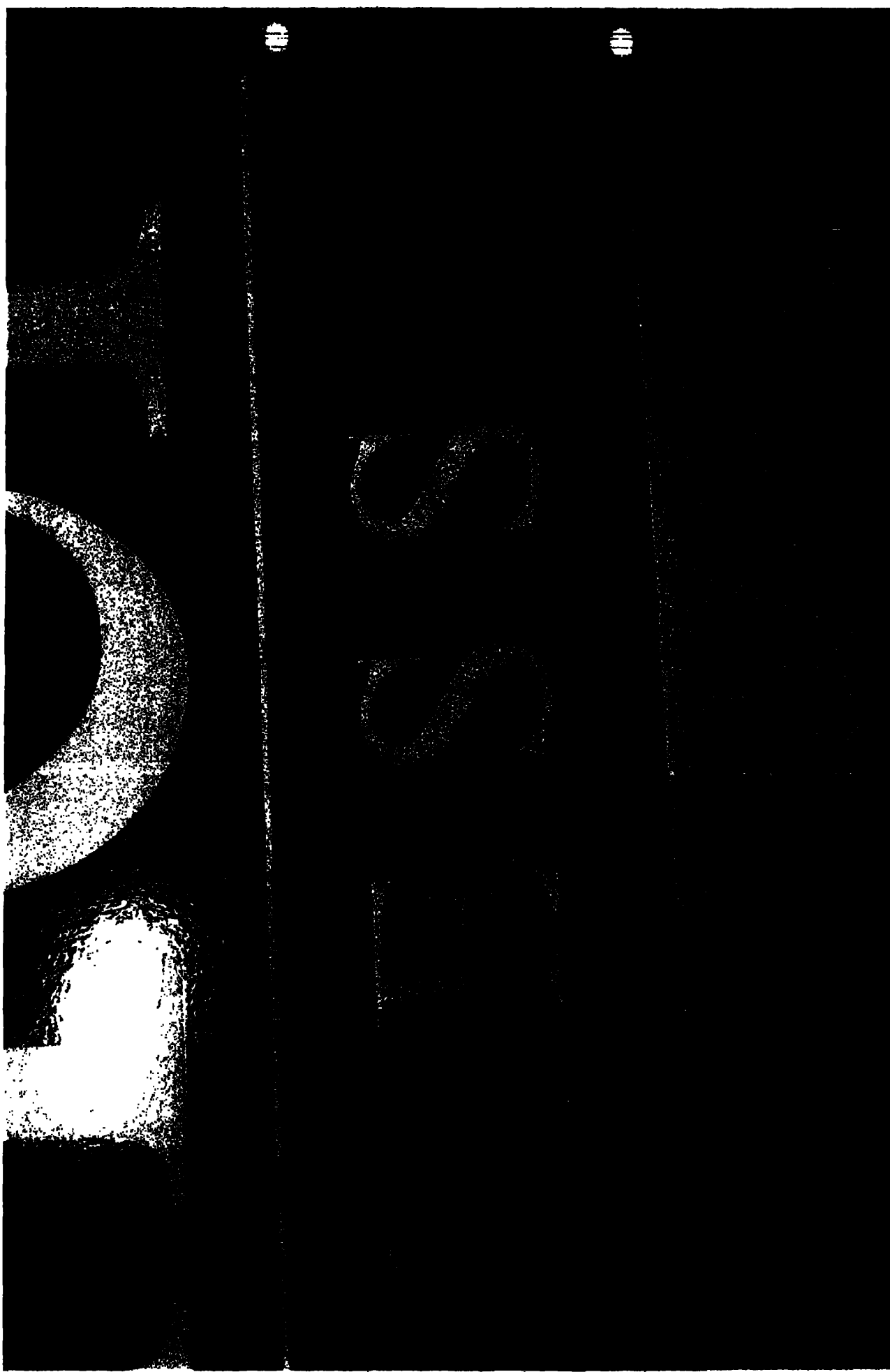

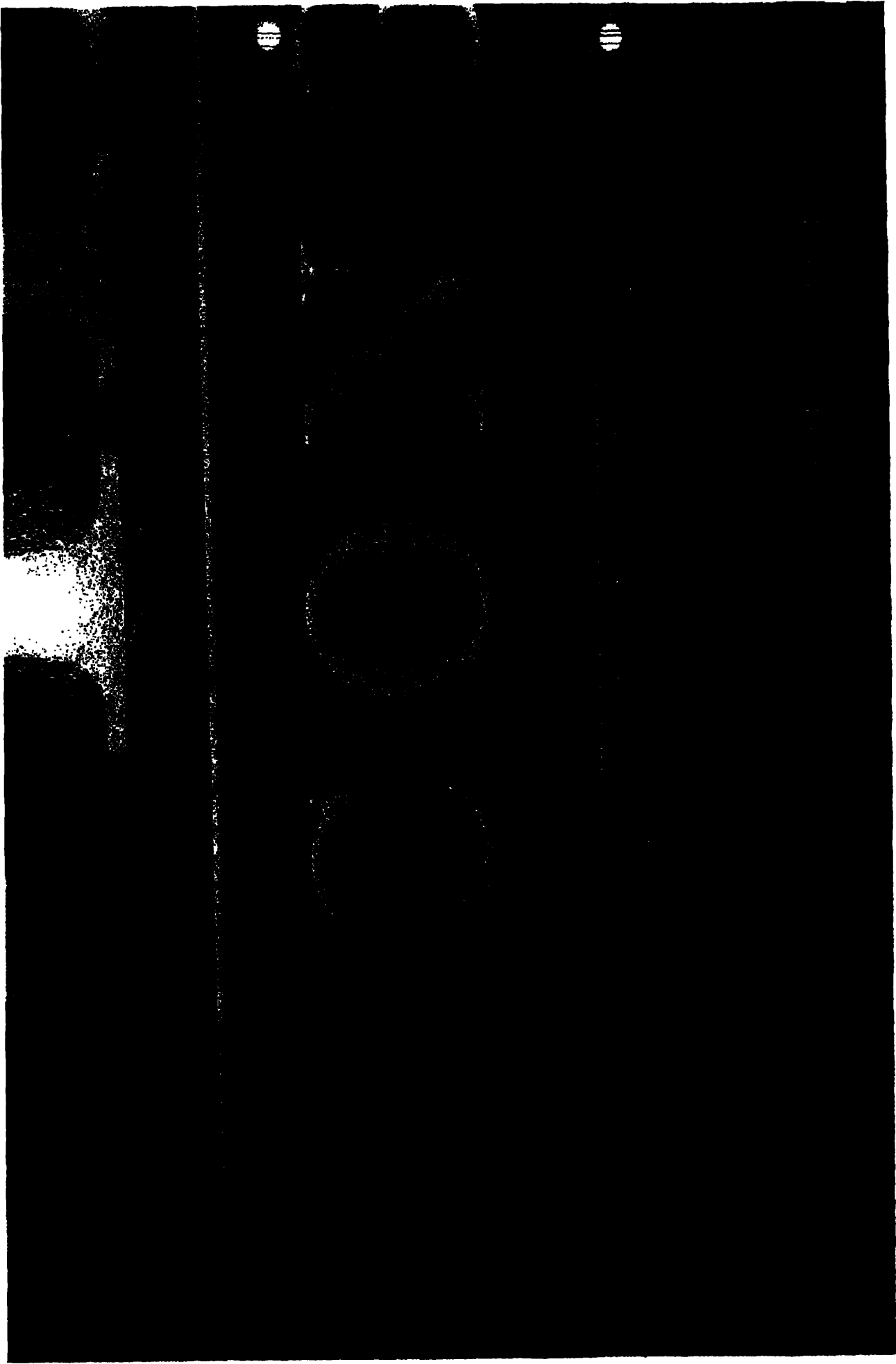

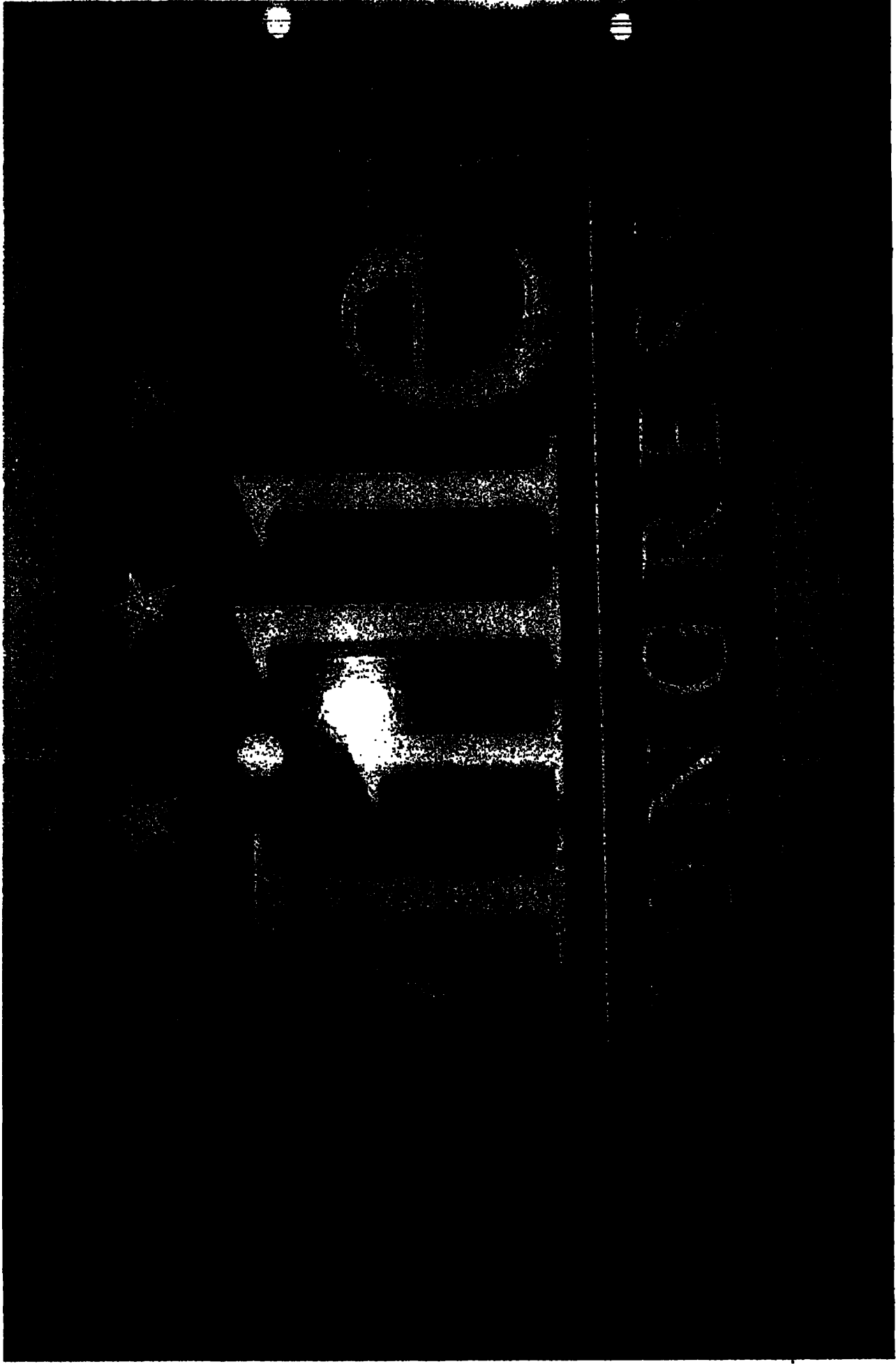
