Dear Sirs;

Please consider this to be a formal complaint of possible violation of the Federal Election Commission regulations regarding the campaign finance activity of the "Dean Black for Congress" Committee.

It appears from the FEC receipt page that this Campaign Finance report has been filed late. It was postmarked April 16, 2010 and was due to be filed no later than April 15, 2010 for the 1<sup>st</sup> quarter ending on March 31, 2010.

Additionally, it appears from this report that Mr. Black's campaign is also in violation of the filing requirements of FEC Form 1 to declare his campaign finance committee within 10 days as required by law after the FEC Form 2 is filed declaring his candidacy for the Office.

Secondly, after researching this FEC Form 3 report, Mr. Black's campaign has received and accepted (2) donations that appear to be from Corporations with no resulting refunds of those donations.

On March 1, 2010, this campaign reported a \$500 donation from:

Also on March 8, 2010, there was another \$500 donation accepted from:

TJSR Enterprises Inc.  
7532 103<sup>rd</sup> St.  
Jacksonville, Fl. 32210

No refund of either of these donations is reflected on the "Refunds of Contributions" section of his FEC Form 3 filing.

Accepting donations from Corporations is prohibited by Federal Election laws and these violations, if left unchecked, will allow Mr. Black a significant advantage in fund raising over all opponents. I feel this possible blatant disregard for the

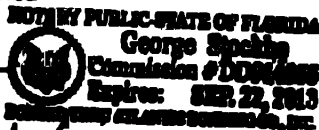
