Re: Philip Liberatore, Liberatore for Congress Committee, and IRS Problem Solvers, Inc.

Dear Ms. Duncan:

Pursuant to 2 USC § 437g(a)(1) and 11 CFR § 111.4, please accept this letter as a Complaint against Philip Liberatore ("Liberatore"), Liberatore for Congress Committee ("the Committee"), and IRS Problem Solvers, Inc. ("the Corporation") for operating in violation of the Federal Election Campaign Act of 1971, as amended (the "Act"), and Federal Election Commission ("FEC" or "Commission") regulations. More specifically, Liberatore, the Committee, and the Corporation have violated various FEC regulations, including, but not limited to, regulations setting forth filing dates, prohibiting corporate contributions, and requiring the accurate and timely reporting of various contributions and expenditures.

I. Facts

Liberatore for Congress Committee is the principal campaign committee for Philip Liberatore, a candidate for the United States House of Representatives, campaigning to represent California's 42th Congressional District. The Committee's FEC Form 1 Statement of Organization was filed with the FEC on January 15, 2010. Liberatore's FEC Form 2 Statement of Candidacy was filed with the FEC on December 10, 2009.

II. Failure to Timely File a Quarterly Report

The Committee filed its 2010 April Quarterly Report ("the Report") on April 19, 2010.

Once an individual becomes a candidate, or files a Statement of Organization, his principle campaign committee must file quarterly reports. 11 C.F.R. § 104.5(a)(1). Quarterly reports must be filed no later than the 15th day following the close of the calendar quarter. §104.5(a)(1). Therefore, the report for the first calendar quarter of 2010 was due on April 15, 2010.

The Committee violated federal law by failing to file its 2010 April Quarterly Report on time. The Report was due on April 15, 2010, and the Committee filed the Report on April 19, 2010.

III. Illegal Corporate Contributions

On Schedule A of the Report, the Committee reported three contributions from corporations. On page five of the Report, the Committee reported a contribution in the amount of \$250.00 from Cerenzia Foods Inc. The memo entry for the contribution says "POSSIBLE ILLEGAL SOURCE". On page eight of the Report, the Committee disclosed a receipt in the amount of \$250 from Nameplate, Inc. Similarly, the memo entry for this receipt says "possible illegal source." Finally, on page nine of the Report, the Committee reported a contribution in the amount of \$250 from KIS Logistics Inc., and noted "possible illegal contribution" in the memo entry section.

The Act and FEC regulations define contribution to include "any gift, subscription, loan, advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for Federal office." 2 USC § 431(8)(A)(i), 11 CFR § 100.52(a). Corporations are prohibited from making contributions to federal political committees, and federal political committees are prohibited from knowingly accepting or receiving contributions made from the general treasury funds of corporations. 11 CFR § 114.2 (a), (d):

By accepting three contributions from corporate entities, and noting on the Report that the contributions are illegal, the Committee has knowingly and willfully accepted contributions from corporate entities in violation of the Act and FEC regulations.

IV. Contribution of or Expenditure for a Campaign Bus

On the wall of Liberatore's Facebook page, located at <http://www.facebook.com/liberatoreforcongress#!/liberatoreforcongress?v=wall> and included as *Attachment 1*, there are many announcements made about the "Liberty Bus". On April 6 at 8:00 p.m., Liberatore for Congress 42 District CA posted "The Phil Liberatore Liberty Bus is heading out on tour this weekend. Let me know if you want a ride." On April 13, Liberatore for Congress 42nd District CA posted "Liberty Bus heading out to the TEA PARTY this Thursday night. Meet me the campaign [sic] in Boca on Birch st. at 3:30 to ride over in luxury. Let us know who is in!". A picture of the Bus is attached as *Attachment 2*.

FEC regulations require that campaign treasurers file periodic complete and accurate reports and statements of their campaign receipts and disbursements. 11 C.F.R. § 104.14(d). Authorized committees must disclose receipts for the current reporting period on FEC Form 3. The authorized committee must report total amounts received, and also must itemize certain receipts on Schedule A. 11 C.F.R. 104.3(a)(3), (4). Similarly, authorized committees must disclose disbursements for the current reporting period on FEC Form 3, reporting both the total amount of disbursements and certain itemized disbursements on Schedule B. 11 C.F.R. §§ 104.3(b)(2), (4).

The Report filed by the Committee does not disclose any receipt related to the Liberty Bus, nor does it disclose any disbursement by the Committee for the cost of the Liberty Bus. If the Committee received the Liberty Bus, it would certainly qualify as a contribution, as it is clearly something of value and used for the purpose of influencing an election for Federal office. 11 CFR §100.52(a). If the Committee instead purchased the Liberty Bus, it would be required to report the expenditure on Schedule B of the Report. Regardless of how the Committee came into possession of the Liberty Bus, it is exceedingly clear that the Committee failed to report the receipt or expenditure on its 2010 April Quarterly Report, and is thus in violation of federal law.

The Committee's failure to report this item that is apparently integral to its campaign effort leads one to believe that there may be additional impermissible activity going on. For example, if the Liberty Bus was contributed by a corporation, this would be an illegal corporate contribution. 11 CFR §114.2 (a), (d). Alternatively, if the Committee purchased the Liberty Bus from a corporation at less than fair market value or at a discounted price, the amount of the discount would also be an impermissible corporate contribution. 11 CFR §100.52(d)(1).

V. Failure to Report Illegal In-kind Corporation Contribution

In late March, Congressman Gary Miller received a letter, dated March 17, 2010, signed by Liberatore and printed on the Corporation's letterhead ("the Letter"). See Attachment 3. The Corporation's logo is printed in the top left hand corner of the Letter, and the Corporation's address and contact information are printed in the top right corner. In the Letter, Liberatore sets forth a few campaign ideas, and tells readers that he hopes he "can count on [their] support on June 8th." June 8, 2010 is the date of the federal primary election in California. The disclaimer on the letter states "Paid for by the Liberatore for Congress Committee 2010."

Upon information and belief, the Letter was sent to some or all of the individuals associated with entities that are members of the Brea Chamber of Commerce. In the Letter, Liberatore states that "We have recently joined the Brea Chamber of Commerce, and we look forward to developing a supportive business relationship." See Attachment 3.

IRS Problem Solvers, Inc. is an incorporated tax organization in La Mirada, California. See the Corporation's website, located at <http://www.yourirsproblemsolvers.com/index.php>. Liberatore is the President of the Corporation. See Attachment 4, screen shot taken from the Corporation's website on April 23, 2010.

As stated above, corporations are prohibited from making contributions to federal political committees, and federal political committees are prohibited from knowingly accepting or receiving contributions made from the general treasury funds of corporations. 11 CFR § 114.2 (a), (d). The Committee's Report did not include any


disbursements to the Corporation for use of its stationary. If the Committee did not reimburse the Corporation for use of the stationary, the Corporation has made and the Committee has accepted an illegal in-kind contribution in the amount of the cost of the stationary.

IV. Conclusion

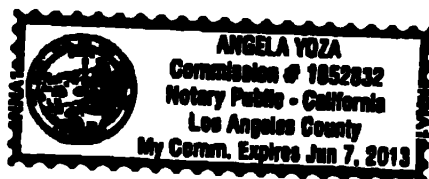
Upon information and belief, and based upon the facts relayed herein, Philip Liberator, Liberator for Congress Committee, and IRS Problem Solvers, Inc. have violated the Federal Election Campaign Act of 1971, as amended, and Federal Election Commission Regulations. Accordingly, we respectfully request that the Commission conduct an immediate investigation into the violations outlined above and impose the maximum penalty under law.

The foregoing is correct and accurate to the best of my knowledge, information and belief.
