
Summary of Complaint: Mr. Liberatore is using his campaign and campaign contributions for the purpose of promoting his business IRS Problem Solvers, Inc.

The complainant, Michael Cargile, received a letter on April 12, 2010 from the respondent, Philip Liberatore, President of IRS Problem Solvers, Inc. The letter, mailed out to more than 700 chamber members, details Mr. Liberatore's campaign for Congress in the 42nd District. The letter, dated February 24, 2010, was written on IRS Problem Solvers, Inc. letterhead. Mr. Liberatore is the owner of IRS Problem Solvers, Inc. The letter specifically references "Paid for by the Liberatore for Congress Committee 2010."

In addition, Mr. Liberatore filed suit against the Secretary of State of California for its rejection of Mr. Liberatore's ballot designation. Mr. Liberatore listed "IRS Problem Solvers" as his official ballot designation. The Secretary of State of California rejected this designation. Mr. Liberatore filed suit with the assertion that he is known in the community as the IRS Problem Solver and he has spent years building the name of his company, IRS Problem Solvers, Inc. The court rejected Mr. Liberatore's claims. Mr. Liberatore's press release is attached for your review.

Mr. Liberatore is attempting to circumvent the decision of the Secretary of State and the courts of California to protect his company through campaign advertising. This is a blatant disregard of both state of California election laws as well as Federal Election Commission regulations.

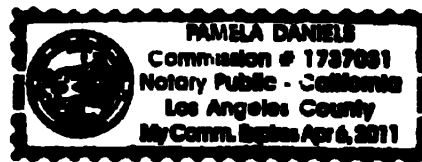
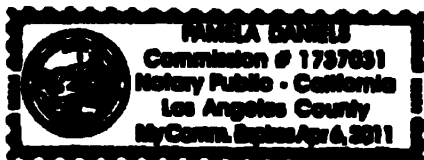
