Looking at Charles R. Grice's 7/19/10 letter, he is alleging that Jerry Morgensen, Hensel Phelps and other unnamed individuals who had already donated amounts to Ken Buck in excess of \$2,400, have provided "funds" to DA and other entities subject to the FEC complaint.

Grice is alleging that Morgensen, Phelps and others sent Declaration Alliance monies, and then Declaration Alliance coordinated political action with the Buck campaign using those monies.

The allegations against Declaration Alliance made by Mr. Grice are untrue, and as DA's President, and also as an attorney licensed in five states, I can say that if the complainant is alleging only that Declaration Alliance has received monies from Morgensen or Phelps, then Mr. Grice's complaint is baseless from a factual standpoint, as Declaration Alliance has received no such donations.

Not only does Grice need to prove factual allegations against Morgensen and Phelps donating to Declaration Alliance to justify his FEC complaint, he also needs to prove that even if Declaration Alliance had received such monies from Morgensen and/or Phelps, he also must prove

Declaration Alliance "coordinated" receipt of these Morgensen and/or Phelps monies with the Buck for U.S. Senate campaign.

No one from Declaration Alliance has met with the Buck U.S. Senate campaign to coordinate action, as prohibited by 2 U.S.C. 441(a) et al.

Grice's baseless complaint against Declaration Alliance and the individuals is based on alleged statements by unnamed "prospective campaign consultants", not heretofore known as members of society valued for their factual integrity, first and foremost.

The Bjorklund deposition transcripts concern allegations against unnamed individuals challenging Jane Norton's petition signatures; what does this deposition have to do with the Grice allegations against Declaration Alliance?

If Grice has trustworthy witnesses willing to testify, why doesn't he name them in his complaint?

Grice's complaint against Declaration Alliance should be dismissed on both factual and legal grounds, and he should not be making accusations which are not well grounded in fact against certain people, which could trigger libel actions against himself by Morgensen and Phelps for asserting they committed actions with regard to Declaration Alliance, which we can say they did not perform in any way.

We ask respectfully for the FEC to dismiss Mr. Grice's unsubstantiated allegations against Declaration Alliance.
