Pursuant to your letter of June 2, 2010, the Liberatore for Congress Committee ("the Committee") hereby responds to the fourth complaint filed by Kerry J. Wilson dated May 27, 2010. This response incorporates all comments from the entities named in the above complaint.


Mr. Wilson assertions are false and are part of a pattern of harassment of the Libertore Committee by Mr. Wilson.

Corporate entities controlled by Phillip Liberatore (Phillip Liberatore, CPA or IRS Problem Solvers, Inc.) have never made contributions to the Liberatore for Congress Committee. In accordance with the Federal Election Campaign Act and Commission regulations, the Committee has reimbursed the corporate entities for the fair market value of all the resources used by the Committee during the course of the Campaign- including postage and use of the mailing permit. Reimbursement by the Committee was made on June 4, 2010 and covers the entire period of use by the campaign. The payment was made in a reasonable period of time and in concurrence with the payment made by the corporate entities to the postal metering vendor. Disclosure of the payment for \$1320.00 was made on the July 15, 2010 quarterly filing as required by the Act and regulation.

In conclusion we urge that the FEC close the MUR without further action.

The foregoing is correct and accurate to the best of my knowledge, information and understanding.
