Dear Office of General Counsel:

This letter is in response to the above-referenced complaint. Ms. Angela Graham has alleged that her name and signature were used on documents without her knowledge and permission for the Vernon Jones for Georgia Committee. This statement is entirely false.

In December 2006, I called Ms. Graham one evening after having a conversation with Mr. Vernon Jones (the candidate) regarding the treasurer duties. Mr. Jones had informed me that Ms. Graham said she would be his treasurer. She had a history of playing a vital role in previous campaigns. Prior to this U.S. Senate campaign, Ms. Graham served as campaign manager for the re-election of Mr. Jones as Chief Executive Officer of DeKalb County, Georgia. When I spoke with her, she confirmed she would be the treasurer; however, she would only do it if she didn't have to be bothered with the paperwork. She stated she had previous problems with paperwork on another campaign and didn't feel like dealing with that again. I told her I would handle all documents for her, and make sure the required reports were filed for her. (At the time I was listed as the administrative assistant for the campaign.) She stated to me that would be fine with her. When I would contact Ms. Graham about meeting her to get her signature for the documents, she told me to just sign her name.

As the campaign continued, Mr. Jones informed me around July 3, 2008 that Ms. Graham no longer wanted to be named the treasurer nor be involved with the campaign because she was too involved with other matters. She was immediately removed by filing an amended Statement of Organization on July 3, 2008, which was received by the FEC on July 9, 2008.

I am appalled that Ms. Graham would make such serious allegations that are emphatically untrue. Nothing was done without Ms. Graham's permission or knowledge. We even provided her personal cell phone number on the Statement of Organization should she need to be contacted (see attached). If we didn't have her permission, we certainly wouldn't have provided her personal number. It is my belief that Ms. Graham has chosen to make these false allegations due to political differences, because she is now working on the campaign of the incumbent in which Mr. Jones is now running against. Therefore, I believe no action should be taken in this matter, and respectfully request that this complaint be dismissed.
