To Whom It May Concern:

Please be aware of numerous possible elections' law violations by Dean Black, 3832-10 Baymeadows Road, Suite 376, Jacksonville, FL 32217, a candidate in the 3rd Congressional District of Florida. I am deeply concerned that Mr. Black may have knowingly and willingly violated campaign law in the following ways:

On 3/1/10 Mr. Black accepted a corporate contribution from Power Solutions Electric, Inc. for \$500.00 (Page 5, Sec. A, Black FEC Form 3, submitted 4/13/10)
On 3/8/10 Mr. Black accepted a corporate contribution from TJSR Enterprise, Inc. for \$500.00 (Page 6, Sec. A, Black FEC Form 3, submitted 4/13/10)
On 3/31/10 Mr. Black accepted a contribution of \$2388.88 which has not been attributed to any source. (Page 9, Sec. B, Black FEC Form 3, submitted 4/13/10)
Page 2, Line 7 of Mr. Black's FEC Form 3 notes \$2,874.06 of net operating expenditures. Mr. Black lists only a disbursement of \$2400.00 to Mr. Edward Cunningham on 4/13/10 on Page 12, Sec. A of his FEC Form 3, a difference of \$9,474.06 in unreported disbursements.
Mr. Black lists 3832-10 Baymeadows Road, Suite 376, Jacksonville Florida 32217 as his campaign address. This is a corporate office. Mr. Black has no disbursements for office rental, electricity, phone service, internet or any other normal and customary expenses related to maintaining an office.
Mr. Black has for months had a fully operational website, yet shows no disbursements for internet hosting or web site hosting.
Mr. Black shows no expenditures for either cellular or land line business phone service.
Mr. Black shows no expenditures for any type of printing normally associated with a campaign.
Mr. Black shows no expenditures for meals, travel or event fees normally associated with a campaign. As the 3rd district stretches from Jacksonville to Orlando and as Mr. Black lives in Jacksonville but has attended events in Orlando, it is safe to presume that he has at the very least incurred the cost of a tank of gas.

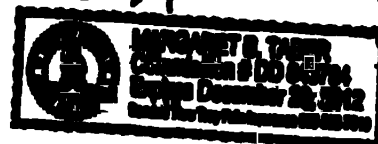
Your immediate attention to these possible violations of Federal elections law is appreciated.
