This is in response to the complaint that was filed by Michael Carnahan against Pridemore For Congress, with the Federal Election Commission.


When Craig Pridemore, currently a Washington State Senator, decided to run for congress in Washington's third congressional district, he had very little money and a very small campaign staff. Some mistakes were made at the beginning of the campaign, before he even brought on his campaign manager. Some remit envelopes and campaign advertising did not have the proper FEC disclosure. For example the remit envelopes mentioned the Washington Public Disclosure Commission instead of the Federal Election Commission. (An old campaign remit envelope was used for the example and the PDC listing was overlooked.)

These mistakes were soon discovered and corrected. I am attaching a copy of the corrected remit envelope that was used for most of his campaign.

We ask that you consider this matter closed. The mistakes made were minor and Craig Pridemore has recently dropped out of the race due to a lack of campaign funds. We are in the process of winding down the campaign and filing a termination report. Nothing was done intentionally to mislead and beginning mistakes made early in the campaign were corrected.

Please let us know if there is any other documentation that you need.
