This is to notify you of a false FEC report filed by Randall for Congress campaign and a formal complaint against William Alfred Randall, II and the Randall for Congress Committee. William (Bill) Alfred Randall, II, is a candidate for the 13th US Congressional District in NC.

December 2, 2009, Joe Teague and I went shopping with Bill Randall and his wife Wendy, at Triangle Mall in Raleigh, NC for the purpose of purchasing clothing for candidate (Randall). We shopped at Joseph A. Bank, Macy's, Saks, etc., and settled on clothing from Dillards. We purchased the following, which totaled \$661.59 and Randall put it on his personal credit card.

- 1 Navy blue striped suit
- 1 Navy blue blazer
- 2 White shirts (without button down collars)
- 2 Neckties (one with yellow stripes and one red with small background designs)
- 1 Pair gold cuff links

Randall immediately got reimbursed \$661.59 on December 2, 2009. He couldn't even wait until his credit card statement came. On his FEC report for period ended December 31, 2009, he listed the \$661.59 as "mileage". It was clearly for clothing, because as I said, I (plus Joe Teague and his wife Wendy) were with him and I heard the sales person give him the amount of sale. This could also be verified by looking at his personal credit card statement for that period, of which I cannot provide a copy.

Also, Randall called me in early July, 2009, asking me to "work" on his campaign. He said I would be paid; that I would have direct access to him, but the campaign manager Melodye Aben had the final say.

Melodye Aben and I discussed my salary. She offered and I agreed on \$75,000 for the duration of the campaign, which would be 16 months. We worked together, using my home for meetings and a place for volunteers to work. I took Randall around, introducing him to contributors (I was the only person on the committee, who had ever worked on a campaign before) trying to help him raise funds. My job was supposed to be Field Operations Director, but I was also asked to work on events. Near the end of August, 2009, Ms. Aben and I were ready to quit, because Randall wasn't trying to raise funds to pay us or buy supplies...nor would he work on a message, etc., although we were working day and night. He fired Ms. Aben and hired Mr. William Warner as campaign manager. I stayed longer, because with a new campaign manager, we thought we could get Randall to get on a message and start raising funds. I did not have a "written" contract, but Ms. Aben and another person, can verify my salary, because it was discussed during a meeting at my kitchen table. Mr. Warner, Ms. Aben and I were the only personnel who worked full time. Others volunteered and were part time, as far as I know.

Sometime in October (?), Mr. Warner (who DID have a written contract) met with me to discuss my salary and I told him that it was already confirmed, with the former campaign manager, Ms. Aben. Numerous times during the 8 months I worked on the campaign, I mentioned that I could not continue working the hours I was working and not receiving payment, because due to these hours, I was not able to earn money elsewhere; while spending money from my pocket to help the campaign, so everyone, including Randall...clearly knew I expected to be paid and was NOT a volunteer.

Mr. Warner and I met often and on December 14, he told me he was leaving and was going to ask Randall to drop out of the race, because of his inability to raise funds (he nor I had ever been paid anything), not having a grasp on the issues, etc. I told him that I would go ahead and leave with him, because I didn't see where there would be a change before the end of the year in which I had already told Warner I would leave by then, if Randall didn't raise sufficient funds.

December 19, I sent an email to Randall, copying the treasurer....resigning and with a request for my salary and expenses. I also sent expenses and salary invoice by registered mail to the Treasurer at the campaign PO address. I received an email from treasurer, indicating she had received my paperwork.

Neither of my invoices were included on the FEC report for period ended December 31, 2009. I feel that listing clothing as mileage and refusing to list my invoices as expenses or debts is a violation of the rules. He did not want to list my invoices, because his FEC report looked really bad as it was and since I didn't have a "written" contract, he felt he could get away with not listing it, in order to make his report look better. I had told him and the campaign that the party would run someone at the beginning of the year, if he didn't prove his ability to raise funds and he was trying to make the report look as good as possible and also, he didn't want to pay me, since I left him. I'm seriously considering a lawsuit, but feel I would be wasting my money, since he'll never raise the funds to pay me.

Enclosed are my two invoices \$29,437.50 and \$1,018.75 and a copy from Randall's FEC filing showing the clothing \$661.59 listed as mileage. I was reimbursed \$418.00 of the \$1,018.75 expense invoice, so that's proof that he received them, because they were in the same envelope. Also, included are emails to Randall and from treasurer indicating invoices were received.

I also question where he got the \$11,500 that shows on his FEC report as a personal loan from Randall, since if he didn't have funds to buy himself clothes to look presentable and had to be reimbursed immediately for them, where did he get the \$11,500 to make a personal loan to the campaign?

I know that there are campaigns whose contributions and expenses are so much greater than this, but we cannot have people lying on government reports, to hide the truth from voters, no matter what the amount is.



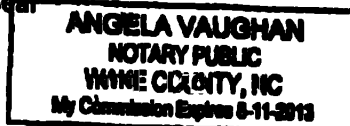
