Re: Complaint Regarding Possible Violations of the Federal Election Laws

Dear Ms. Duncan:

I, Edward R. Martin, Jr., file this complaint on behalf of the Ed Martin for Congress Committee, under 2 U.S.C. section 439a(b), 11 C.F.R. 110.1(e) and 11 C.F.R. 110.1(g). Ed Martin is a Republican candidate for Congress in the 3rd district of Missouri. The respondent is Congressman John Russell Carnahan, the congressman for the 3rd congressional district in Missouri and a Democratic candidate for the 3rd congressional district for the 2010 federal election.

BACKGROUND

This complaint is based on two categories of violations of federal election law by Congressman Russ Carnahan and the Carnahan for Congress congressional campaign. The first category of violations is based on evidence showing that Congressman Russ Carnahan converted campaign contributions into personal use. Congressman Russ Carnahan used campaign contributions during the 2004 congressional election to pay rent to a Missouri limited liability corporation that was formed, controlled and owned by Congressman Russ Carnahan, his wife, Debra Carnahan, and two other partners.

On January 1, 2003, Congressman Russ Carnahan formed a Missouri limited liability corporation named Castle Ballroom Development, LLC. See Articles of Organization, Attachment A; see also Certificate of Organization, Attachment B. The sole purpose of this corporation was to "own and develop the former Castle Ballroom building at 2839-41 Olive Street, and any other lawful purpose." See Attachment A. After incorporating the Castle Ballroom Development, LLC with the Missouri Secretary of State's Office, Congressman Russ Carnahan signed a contract with Clayton Investment Corporation to buy the Castle Ballroom building with a Seller Take-Back loan for \$146,250. See Deed Record for County, Attachment C. Congressman Russ Carnahan, Debra Carnahan, Mary Entrop, and Lewis E. Reed, were all partners/members in Castle Ballroom Development, LLC. See General Warranty Deed, Attachment D.

In five different campaign reports in 2003 and 2004, Congressman Russ Carnahan reported that he made 12 different payments totaling \$10,490 for rent to Castle Ballroom Development, LLC. See Carnahan for Congress Campaign Committee, "Amended July 2003" Federal Elections Commission Report, Schedule B at page 33, Attachment E; see Carnahan for Congress Campaign Committee, "Amended October 2003" Federal Elections Commission Report, Schedule B at pages 52-53, Attachment F; see Carnahan for Congress Campaign Committee, "Year End 2003" Federal Elections Commission Report, Schedule B at pages 34-35, Attachment G; see Carnahan for Congress Campaign Committee, "Amended April 2004" Federal Elections Commission Report, Schedule B at pages 68-69, Attachment H; and see Carnahan for Congress Campaign Committee, "July 2004" Federal Elections Commission Report, Schedule B at page 87, Attachment I. Congressman Carnahan's use of campaign contributions to pay rent for a building that was owned and controlled by a corporation in which he and his wife were partners and, thus, beneficiaries, violates both the spirit and intent of 2 U.S.C. section 439a(b)(2)'s prohibition of conversion of campaign contributions to personal use.

The second category of violations of federal election law by Congressman Russ Carnahan is based on a \$1,200 campaign contribution from Castle Ballroom Development, LLC to the Carnahan for Congress campaign committee, Congressman Russ Carnahan's 2004 campaign committee, on December 1, 2004. See Carnahan For Congress Campaign Committee, "Year End 2004" Federal Elections Commission Report, Schedule A, at page 8, Attachment J. As stated above, Castle Ballroom Development, LLC was a Missouri limited liability corporation formed by Congressman Russ Carnahan on January 1, 2003. See Articles of Organization, Attachment A; see also Certificate of Organization, Attachment B. For tax purposes, Congressman Russ Carnahan chose to not have Castle Ballroom, LLC taxed as a corporation. See Attachment A. Congressman Russ Carnahan, Debra Carnahan, Mary Entrup, and Lewis E. Reed, were partners/members in Castle Ballroom Development, LLC. See General Warranty Deed, Attachment D.

POSSIBLE VIOLATIONS OF FEDERAL CAMPAIGN LAWS

Federal election laws detail the permissible and prohibited uses of campaign contributions. In general, candidates for federal office can only use campaign contributions for authorized, ordinary and necessary expenditures in connection with a campaign for federal office or for permissible transfers to other campaign committees or candidates. See 2 U.S.C. section 439a(a)(1)-(6). However, federal law strictly prohibits candidates from converting campaign contributions to personal use. Specifically, federal law defines "prohibited use" and "conversion" as follows:

(b) Prohibited use.

(1) In general. A contribution or donation described in subsection (a) shall not be converted by any person to personal use.

(2) Conversion. For the purposes of paragraph (1), a contribution or donation shall be considered to be converted to personal use if the contribution or amount is used to fulfill any commitment, obligation, or expense of a person that would exist irrespective of the

candidate's election campaign or individual's duties as a holder of Federal office, including --

- (A) a home mortgage, rent, or utility payment;
- (B) a clothing purchase;
- (C) a noncampaign-related automobile expense;
- (D) a country club membership;
- (E) a vacation or other noncampaign-related trip;
- (F) a household food item;
- (G) a household food item;
- (H) admission to a sporting event, concert, theater, or other form of entertainment not associated with an election campaign; and
- (I) dues, fees, and other payments to a health club or recreational facility.

2 U.S.C. section 439a(b).

Applying the above prohibitions against use of campaign funds, Congressman Carnahan broke Federal election laws in converting contributions for public office into personal use. Congressman Russ Carnahan violated 2 U.S.C. section 439a(b)'s prohibition against using federal campaign contributions for personal use by transferring \$10,400 in campaign contributions to pay rent for a building owned by Castle Ballroom Development, LLC, a company that was controlled and owned by Congressman Carnahan, his wife and two other partners. See Attachment E at page 33; Attachment F at pages 52-53; Attachment G at pages 34-35; Attachment H at pages 68-69; and Attachment I at page 87; see also General Warranty Deed, Attachment D. This violation was intentional and willful.

The second violation of federal election laws by Congressman Carnahan is attributed to his failure to follow the strict reporting requirements of Federal election laws on federal contributions from limited liability corporations that are deemed partnerships. A contribution by a limited liability corporation that elects to be treated as a partnership by the Internal Revenue Service, or does not elect treatment as either a partnership or a corporation, is considered a contribution from a partnership pursuant to 11 C.F.R. 110.1(e). See 11 C.F.R. 110.1(g)(2). If a limited liability corporation that elects to be treated as a partnership or does not elect to be treated as a corporation makes a contribution to a federal campaign committee, then the limited liability corporation must provide the recipient campaign committee with information as to "how the contribution is to be attributed, and affirm to the recipient committee that it is eligible to make the contribution." See 11 C.F.R. 110.1(g)(5). Furthermore, federal law mandates that a contribution from a partnership

[S]hall be attributed to the partnership and to each partner--

- (1) In direct proportion to his or her share of the partnership profits, according to instructions which shall be provided by the partnership to the political committee or candidate; or

(i) Only the profits of the partners to whom the contribution is attributed are reduced (or losses increased), and

(ii) These partners' profits are reduced (or losses increased) in proportion to the contribution attributed to each of them.

A contribution by a partnership shall not exceed the limitations on a contribution in 11 CFR 110.1(b), (c), and (d). No portion of such contribution may be made from the profits of a corporation that is a partner.

11 C.F.R. 110.1(e).

Castle Ballroom Development, LLC had four partners/members as shown on a General Warranty Deed. See Attachment D. The Carnahan for Congress campaign committee accepted a \$1,200 donation from Castle Ballroom Development, LLC on December 1, 2004 as reported in the Carnahan in Congress Campaign Committee, "Year End 2004" Federal Elections Commission Report, Schedule A. See Attachment J at 8. The Carnahan for Congress campaign committee violated 11 C.F.R. 110.1(e) and 11 C.F.R. 110.1(g) in failing to properly report Castle Ballroom Development, LLC's \$1,200 campaign contribution in its January 31, 2005 "Year End" Federal Elections Commission report. See Attachment J at 8. The Carnahan for Congress campaign failed (1) to attribute which partner or partners of Castle Ballroom Development, LLC made the contribution to the Carnahan for Congress campaign committee and (2) to require affirmation from Castle Ballroom Development, LLC that it was eligible to make the contribution, and, therefore, violated both 11 C.F.R. 110.1(e) and 11 C.F.R. 110.1(g).

CONCLUSION

I request that the Federal Election Commission take immediate action to determine whether Congressman Russ Carnahan (1) violated 2 U.S.C. section 439a(b)'s prohibition on conversion of campaign contributions to personal use and (2) whether Congressman Russ Carnahan, through his Carnahan for Congress campaign committee, violated 11 C.F.R. 110.1(e) and 11 C.F.R. 110.1(g) in failing (a) to attribute which partner of Castle Ballroom Development, LLC made the contribution to the Carnahan in Congress campaign committee and (b) to require affirmation from Castle Ballroom Development, LLC that it was eligible to make the contribution.

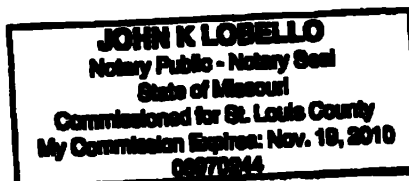

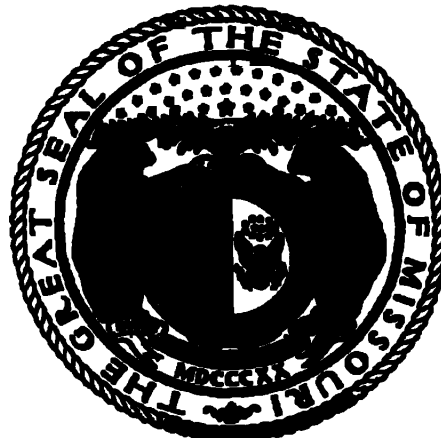
