To Whom It May Concern:


I am writing you today to file a official complaint against *Lowry for Congress, the candidate Robert P. Lowry, and the campaign's manager Chris Leggatt*, for what I believe are two separate violations of existing FEC regulations.

First, on the campaign's Schedule A filling of receipts (included), Mr. Lowry and his campaign received, deposited and filed contributions from four different corporations (marked with an "X"). I believe that this is a clear violation of FEC regulations that forbid federal political campaigns from accepting checks from corporations.

Second, on numerous occasions, Lowry for Congress has published and disseminated banners that lack the disclaimer "Paid for by Lowry for Congress" (photos of these banners are included here as well). It is my understanding that this omission is also a violation of FEC regulations that require a campaign's disclaimer to appear on all printed materials and banners.

I appreciate your time and consideration in this matter.

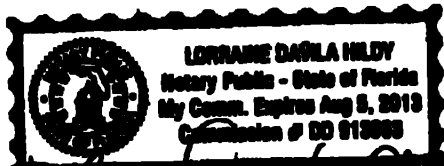

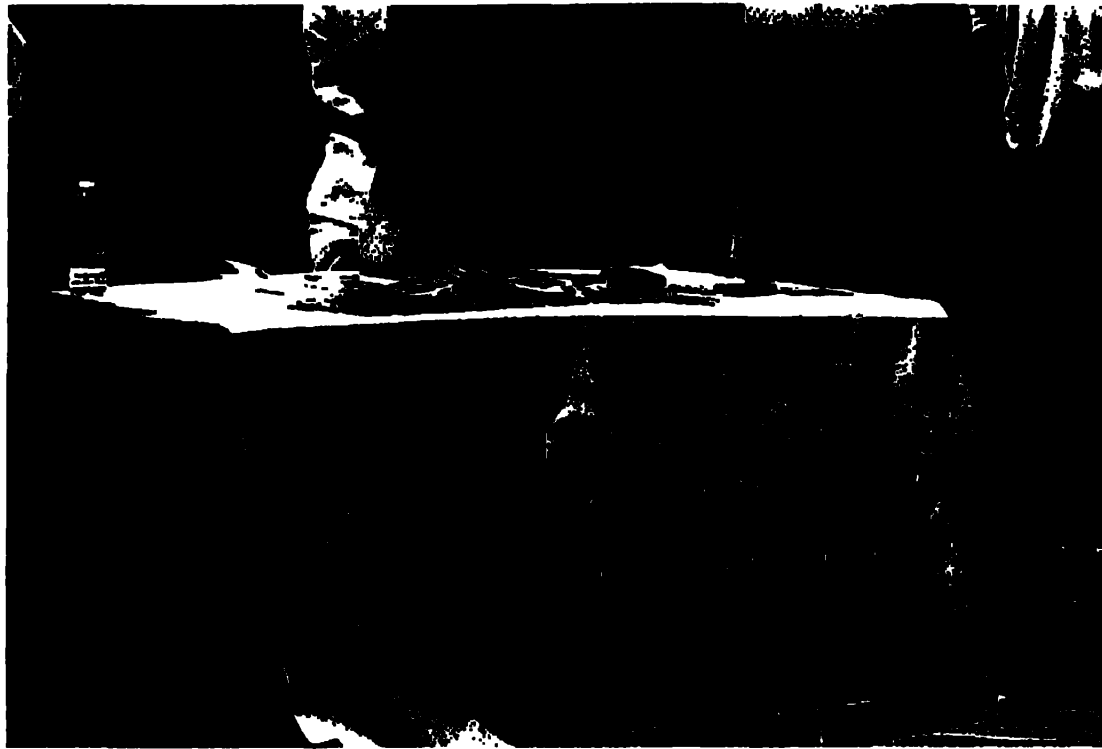
