My name is Jorgine Fields. I am named in this complaint, Re: MUR 6345. I am one of the co-founders of the Keep God In America Rally which was held here in Jacksonville, Florida in March 2010.

My husband and I are self-employed. We lost nearly 2 months of work time over the four months we worked on the Rally. We also had many extra expenses associated with our efforts. Chris Nwarike was the lead organizer, and we were the assistant coordinators.

After the Rally in March, Chris had been wanting to pay my husband and I for our expenses and services for the work we did for Keep God In America which we consistently refused even though our efforts took us to the brink of losing our house and car. We did not do the Rally for ourselves. However, when the time in question came, we did want to help one of the most amazing people we've ever met in our lives to run for office. I took that pay so I could do just that.

The next thing I want to say is that Biblical Concepts Ministries is not recognized as a 501-C3 organization by the Federal government. We had to pay taxes to our vendors. (See attached copies.)

Chris returned the \$2000 to me. He did that on his own even though different advisors told him he didn't have to do that. I put the money back into Keep God In America. It was during the Rally that we watched Chris himself come to a place that he wanted to step up to the plate and do something about his convictions and for America.

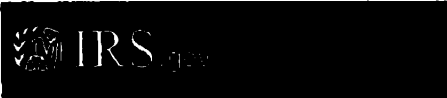
I certainly will be anxious to get your reply.
