Dear General Counsel:

On behalf of the David Schweikert for Congress Campaign and that Campaign's Treasurer, this responds to complaint no. MUR 6348. The complaint was filed by Luis A. Heredia, Executive Director of the Arizona Democratic Party, and it alleges that the disclosure on a piece of campaign literature failed to comply with the conspicuousness requirements of 11 C.F.R. § 110.11(c)(1) & (2).

The complaint is not well-taken and should be dismissed. I enclose a sample of the piece in question. The disclaimer is clear and conspicuous, and adequately informs the reader that the Schweikert Campaign paid for the piece. The disclaimer appears to be in 12-point type, it is set forth in a printed box, the color contrast is adequate, and it appears on the front of the piece. That should satisfy the requirements of 11 C.F.R. § 110.11(c)(1) & (2).


I also enclose the Statement of designation of Counsel, and respectfully request that you address all communications regarding this complaint to me.
