COMPLAINT

In the Matter of:

**Brumberg for Congress
David Ryan Brumberg
Anna Shearer
Dr. Barry Brumberg**

MUR # 6349

David B Douek ("Claimant") hereby brings this Complaint before the Federal Election Commission ("FEC") seeking an immediate investigation and enforcement action against Brumberg for Congress, David Ryan Brumberg, Anna Shearer, and Dr Barry Brumberg ("the Respondents") for serious violations of Federal Election Law

Nature of the Action

- 1 Brumberg for Congress ("Brumberg" or "the Committee") leases approximately 1,000 sq feet of office space in Manhattan ("the Brumberg office space") In direct violation of Federal campaign finance laws, no donations or expenditures relating to this office space were reported in the Committee's July 2010 Quarterly Filing with the FEC**
- 2 The office space has been donated to Brumberg as an in-kind donation**
- 3 The unreported donations far exceed the contribution limits established by the Federal Election Campaign Act ("FECA") and FEC regulations ("the legal contribution limits")**
- 4 Brumberg's failure to disclose the in-kind donations is part of a fraudulent attempt to secretly accept illegal donations that significantly exceed Federal contribution limits**

- 5 By flouting Federal campaign laws, Brumberg's fraud seriously undermines the integrity and legitimacy of the Federal election process
- 6 In light of Brumberg's patently illegal conduct, Claimant requests that the FEC conduct a full investigation of Brumberg's actions, declare the Respondents to have violated the Federal Election Campaign Act and applicable FEC regulations, impose appropriate sanctions, and take any further actions that the FEC deems warranted

The Parties

- 7 Claimant is a citizen of the United States and resides at
New York, NY 10022
- 8 Respondent David Ryan Brumberg is a resident of New York City and a candidate for Congress in New York's 14th Congressional District
- 9 Respondent Brumberg for Congress is David Ryan Brumberg's Principal Campaign Committee (Brumberg for Congress Amended Statement of Organization, Exhibit A)
- 10 Respondent Anna Shearer is the Treasurer of Brumberg for Congress, according to the Committee's Amended Statement of Organization (Brumberg for Congress Amended Statement of Organization, Exhibit A)
- 11 Respondent Dr. Barry Brumberg is the Treasurer of Brumberg for Congress, according to the Committee's July 2010 Quarterly Filing (Brumberg for Congress July Quarterly Report, Exhibit B)

Facts

12. In May of 2010, Brumberg for Congress began leasing approximately 1,000 square feet of office space ("the Brumberg office space") at 20 West 38th Street, Suite 306, New

- York, New York (06/07/2010 Email from David Ryan Brumberg, Exhibit C) ¹ The office space is located in Manhattan's Murray Hill Neighborhood, near Fifth Avenue
- 13 The average cost of leasing similar premises in the vicinity of the Brumberg office space is approximately \$48 per square foot per year (04/01/2009 New York Times Article, Exhibit D) This amounts to a leasing cost of approximately \$40,000 per year or over \$4,000 per month
- 14 Upon information and belief, the imputed value of the Brumberg office space for each of the months of May, June, July, and August is approximately \$4,000 per month Upon information and belief, the total imputed value of leasing this space for these four months is approximately \$16,000 By November, the total value of Brumberg's use of the office space will amount to over \$28,000
- 15 Upon information and belief, Brumberg has received the use of the Brumberg office space as an in-kind donation from a contributor currently unknown to the Claimant Upon information and belief, the value of these donations significantly exceeds the legal contribution limits established by the Federal Election Campaign Act and applicable FEC regulations
- 16 On July 15, 2010, Brumberg filed its Form-3 financial disclosure with the FEC (Brumberg for Congress July Quarterly Report, Exhibit B) The form was signed by Dr Barry Brumberg, who purported to be the Committee's Treasurer Nowhere is the Brumberg office space mentioned in the filing Brumberg failed to disclose the Brumberg office as either a receipt or disbursement

¹ In the email, Ryan Brumberg states that his campaign has "moved into our 1,000 square foot campaign headquarters on 38th and 5th—complete with bright magenta walls! We have 3 small offices and a large working area for all the interns and volunteers "

- 17 Upon information and belief, Brumberg intentionally failed to disclose the office space in an attempt to fraudulently conceal the fact that Brumberg is illegally receiving donations that significantly exceed the legal contribution limits

COUNT I (Failure to Disclose Receipts and Expenditures)

- 18 FECA and FEC regulations require campaign committees to accurately disclose the receipt of donations and the disbursement of funds. See e.g. 2 U.S.C. 434, 11 CFR 104.1, 11 CFR 104.3, 11 CFR 104.8. Any in-kind contribution must be recorded as both a receipt and expenditure. 11 CFR 104.13. Each treasurer is personally responsible for the accuracy of the information provided in the filings. See 11 CFR 104.14.
- 19 The Respondents deliberately violated the abovementioned laws by purposefully failing to disclose any receipts or expenditures relating the Brumberg office space.
- 20 On information and belief, the Brumberg office space was donated by a contributor as an in-kind contribution and thus should have been recorded as both a receipt and expenditure. Respondents failed to do so in direct violation of Federal law.
- 21 At the very least, even if Brumberg paid for the space out of the Committee's own funds, expenditures should have been recorded for each monthly payment made for the Brumberg office space. Again, however, Respondents failed to do so and their failure is a clear violation of FECA and FEC regulations.

COUNT II (Receipt and Acceptance of Excessive Contributions)

- 22 FECA and FEC regulations place strict limitations on the donations a candidate may accept from contributors and prohibit candidates from accepting donations in excess of those limits. See e.g. 2 U.S.C. § 441(a), 11 CFR 110.1, 11 CFR 110.9.

23 The Respondents have accepted donations of or for the Brumberg office space that exceed the applicable legal contribution limits and have thereby violated Federal election laws *See Id*

COUNT III (Fraud)

24 Brumberg's failure to report the donations and expenditures was part of a purposeful plan to defraud the FEC, the Federal Government, and the People of the United States. Brumberg realized that the donation of the Brumberg office space exceeded the legal contribution limit. In order to circumvent these limitations, Brumberg filed deliberately false documents with the FEC that intentionally concealed donations and expenditures related to the Brumberg office space.

25. These violations constitute "knowing and willful conduct" that warrants referral to the Department of Justice. *See* 2 U S C 437g

Cheaper Rents in Manhattan's Less Glossy Office Buildings

During the recent economic boom, rents in the priciest Manhattan office towers skyrocketed. A similar trend occurred in the city's less well-heeled office buildings, known in real estate jargon as Class B buildings. But today, vacancies are rising and rents are falling sharply in both classes of buildings, especially in Midtown.

"I think the general feeling was that Class A was going to get hit" because the economic decline was "first and foremost, a financial industry problem," and that industry tends to favor Class A buildings, said Robert L. Sammons, the managing director in charge of research at Colliers ABR. So he was surprised to notice that Class B rents were swooning just as hard — or harder.

Asking rents for both classes of buildings in Midtown Manhattan almost doubled during the five years from the beginning of 2003 to their peak in early 2008. Then, in the last year, average annual asking rents for Class A office space in Midtown fell 19.1 percent, to reach \$76.54 per square foot by the end of February. In the same period, average asking rents for Class B office space in Midtown fell 28.4 percent, to reach \$48.74 a square foot a year, according to Colliers ABR.

Mr. Sammons said that many Class B buildings were also occupied by financial companies, often for "back office" functions like accounting and human resources.

He pointed to two large Class B blocks that were on the market. He said Wells Fargo had notified the landlord that it would give up a lease expiring at the end of this year for 62,000 square feet in 119 West 41st Street, between the Avenue of the Americas and Broadway. The landlord, George Comfort & Sons, has begun offering this space for direct lease, but has not set an asking rent.

Further west, at 323 West 34th Street, between Eighth and Ninth Avenues, Citigroup has been trying to extricate itself from a lease that expires at year-end for the entire 350,000-square-foot building. SL Green, a large real estate investment trust, purchased the building from Citigroup in a sale-leaseback deal in 2007.

SL Green, which is marketing the space directly to potential tenants, has leased all of the second through fourth floors and part of the fifth, totaling 156,000 square feet, to the Regal Company, a human resources

consulting firm The space on the remaining floors, from the fifth to the 10th floors, is still available

In general, Class B buildings are older, with smaller floor areas than Class A buildings, but the definitions are not rigid. Class B space can be in new buildings in emerging sites or in old buildings in prime locations. Space can even be classified as Class C, but there is not much of that in the major Manhattan office markets, especially not in Midtown.

Manhattan has more than twice as many Class B buildings as Class A buildings, but the amount of Class A space is approximately 50 percent greater because the buildings tend to be much larger. That is especially true in Midtown, which has 163 million square feet of Class A space and 71 million square feet of Class B, according to Colliers.

By now, the economic pain in Class B buildings is not limited to those with a lot of financial tenants. As the recession drags on, it is hurting many industries that dominate Class B office space in Manhattan — including advertising and media companies, law firms and accounting firms.

"Large institutions prefer Class A space, but a lot of media companies prefer Class B space because it's cooler," said Andrew Peretz, an executive vice president at Cushman & Wakefield.

Further pressure could come if some tenants in Class B buildings decide to trade up to Class A buildings as they become more affordable. But brokers say this is not happening as much as they would generally expect by this point in a recession, apparently because many tenants are uncertain about what their space needs will be a year or two from now.

"This is the first time that I have seen a downturn that is as deep in the tenants' psychology," said Mr. Peretz, who represents many buildings for landlords in Midtown South and downtown office submarkets.

But Matt Barlow, an executive vice president at Studley, a brokerage firm that specializes in representing office tenants, said good deals were available for tenants in Class B office buildings who were willing to sublet space in Class A buildings. "It used to be that staying put was deemed to be the low-cost alternative," Mr. Barlow said. "But in this environment, where there is an abundance of prebuilt space, that is changing the natural equation." Moving into a space previously occupied by another tenant can sometimes save a new tenant the expense of finishing off and decorating the area.

The overall vacancy rate — counting sublet space as well as space that is available directly from landlords — has widened more for Class A buildings in Midtown than for Class B. But that is primarily because the market was very tight for the most sought-after space one year ago. The vacancy rate for Class A space in Midtown has jumped to 11.3 percent, from 6.4 percent at this time last year. The vacancy rate for Class B space in Midtown has risen to 14 percent, from 9.9 percent, Colliers AER reported.

R. Stuart Gross, an executive managing director at Eastern Consolidated, a real estate investment services company in New York, pointed out that some owners had purchased Class B buildings in recent years at

very rich prices with the intention of converting them to residential condominiums or limited-service hotels. When the economy was flush, some of these landlords began emptying out these buildings as the tenants' leases expired. Now the owners are unable or unwilling to proceed with the conversions, and they are left with empty space on their hands.

"Because of the slowdown in the condominium marketplace, there is very little financing to convert office to residential now," Mr. Gross said. "So a lot of these will remain office buildings."
