Gentlemen:

I would like to file a complaint against Congressman William Pascrell, Jr., 2464 Rayburn Building, Washington, DC 20515, representing New Jersey's 8th Congressional District for using government funds to mail a campaign brochure

Complainant Roland Straten, _____, NJ 07042, candidate for Congress from New Jersey's 8th Congressional District

Respondent: Congressman William Pascrell, Jr., 2464 Rayburn Building, Washington, DC 20515 and unknown staff

Documentation included: Two copies of the campaign brochure, one sent to Essex County, the other to Passaic County

I am filing an FEC complaint against Congressman Bill Pascrell for using government funds to send out a campaign brochure,

On or about July 31, 2010, Bill Pascrell mailed a 4-page full color campaign brochure to voters in the 8th Congressional district at government expense. It did not contain a Paid for Pascrell for Congress disclaimer, but did contain the following statement "This mailing was prepared, published, and mailed at taxpayer expense."

Since this brochure was sent within 95 days of the election, it meets the technical requirement that no mass mailing may be made within the 90 day limit

**It does not, however, meet the requirement that the franking privilege may only be used for matters of public concern or public service as defined by

CHAPTER 32 - PENALTY AND FRANKED MAIL

(4) It is the intent of the Congress that the franking privilege under this section shall not permit, and may not be used for, the transmission through the mails as franked

mail, of matter which in its nature is purely personal to the sender or to any other person and is unrelated to the official business, activities, and duties of the public officials covered by subsection (b)(1) of this section

And the House Ethics Manual, Chapter 4 page 124

Among the specific activities that already may not be undertaken in a congressional office or using House resources (including official staff time) are the solicitation of contributions, the drafting of campaign speeches, statements, press releases or literature, the completion of FEC reports, the creation or issuance of a campaign mailing, and the holding of a meeting on campaign business. The same prohibition applies to any activity that is funded to any extent with campaign funds, even if the activity is not overtly political in nature. The latter point is addressed further below under the heading —Use for Bona Fide Campaign or Political Purposes

His defense will be that this is a newsletter and not a campaign brochure

I contend that if it walks like a duck, looks like a duck, and quacks like a duck, it is a duck

This is clearly a campaign piece because

- 1) Nowhere in the brochure does it claim to be a newsletter, information piece, or anything other than a piece of campaign literature
- 2) The headline reads "Getting Results for the 8th District of New Jersey"
- 3) Nowhere in the listing of accomplishments is there any detailed or actionable information that a resident could use for his own benefit. The piece has no information that is helpful to a resident on how to obtain government services or specifics on rules and regulations on new bills
- 4) The headline in the middlefold, "REP Bill Pascrell, Jr. Delivering Tax cuts to the working class families and over \$311 million to the 8th District from the recovery act to create jobs and build the foundation of our future" is a clear-cut campaign statement
- 5) The middle fold contains listings of his political accomplishments. It is a listing of money he claims to have brought into the district
- 6) There are two versions of the brochure, one directed at Essex County voters, the other at Passaic County voters. If this were truly an informational piece, the information would be the same for both counties
- 7) Much of the information is non-specific, old and dated. It lists grants that were provided years ago without any instrumentation
- 8) Much of the information is inaccurate and exaggerated with the purpose of convincing the recipient to vote for Bill Pascrell

9) The fact that this brochure was mailed so close to the 90 day limit is a clear indication that the intention was not informational. It is political campaigning.

10) The brochure contains pictures of elected officials and senior citizens, a targeted group, with Bill Pascrell, which is another clear indication that this is a campaign piece designed to influence voters rather than an information piece designed to inform the residents of the district.

11) Most people who opened this brochure felt that it was a campaign brochure and were very surprised to see the at taxpayers expense disclaimer.

All the above statements except for item 11 are based on personal knowledge of the Complainant. Item 11 is based on emails received from supporters.

Based on the above information and complaint, I respectfully request that the Federal Election Commission order Congressman Pascrell to reimburse the government for the cost of this mailing and/or to provide the equal amount of funding to the Straten campaign.


