Dear Sirs:

On July 21st I received an email reply from your office regarding my memorandum on the missing campaign finance report of Rolando Banciella. I had expressed my concern that Mr. Banciella did not file a finance report for the second quarter with the Federal Elections Commission (FEC) and is in violation.

Your office confirmed that a candidate is required to submit a campaign finance report if he or she exceeds \$5,000.00 in campaign contributions or expenditures. The filing fee to run for the United States House of Representatives is \$10,440.00. Mr. Banciella paid that fee. Attached you will find the canceled check for Mr. Banciella's filing fee, as well as, his filing papers for his candidacy for United States House of Representatives.

He has clearly raised or borrowed more than \$10,440. He has also clearly spent at least \$10,440 by paying the filing fee to run for Congressional seat. He is required to file a report.

I am formally filing a complaint against Rolando Banciella, for not filing a campaign finance report.

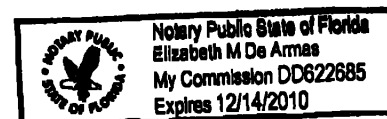

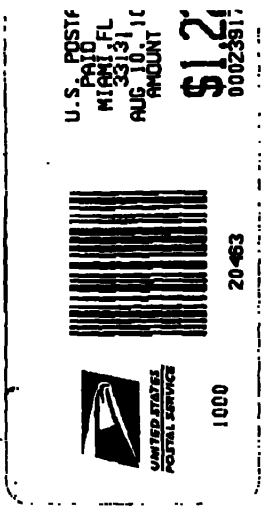
