**RE: Complaint of Candidate David Rivera, Committee "Voters Response"**

Dear General Counsel:

I am filing the following complaint based upon a good faith belief that federal candidate David Rivera and the 527 Committee "Voters Response" have violated federal campaign finance law in at least two ways. First, by coordinating attacks on candidate Joe Garcia and second, by avoiding campaign contribution limits by off-setting campaign expenses through the 527.

David Rivera, a federal candidate currently running for the United States Congress in Florida's 25<sup>th</sup> District.

"Voters Response" a 527 committee headed by Tallahassee lobbyist David Ramba.

### Complaint

1. David Rivera has been questioned about a claim that he was the defendant in a Domestic Violence case.
2. In response to the Domestic Violence questions, Sarah Bascom, the President of Bascom Communications & Consulting has sent out e-mail communications with what purports to be a statement from David Rivera claiming he had nothing to do with the Domestic Violence case. (Exhibit A).
3. Bascom Communication & Consulting is a limited liability company with its registered office located at 108 South Monroe Street, Suite 100, Tallahassee, FL 32301. (Exhibit B).
4. Campaign Finance Reports filed by the David River campaign fail to indicate a payment to Bascom Communications for its Domestic Violence issue response. (Exhibit C).
5. Campaign Finance Reports do however indicate that Bascom Communications was paid \$1,500 on July 29, 2010 by a 527 committee named "Voters Response" with a purported address of 101 South Monroe Street, Tallahassee, FL. (Exhibit D).

6. Voters Response is a registered 527 committee headed by Tallahassee lobbyist David Ramba. (Exhibit E).
7. David Ramba has already donated the maximum legal limit of \$2,400.00 to the David Rivera Campaign. (Exhibit F).
8. Further evidence of finance law violations can be seen in the fact that Voters Response is also responsible for a direct mail piece attacking David Rivera's likely general election opponent, Joe Garcia, Candidate for Florida's 25<sup>th</sup> Congressional District. (Exhibit G)

It is clear from these documents that David Rivera and Voters Response are coordinating campaign activities and off-setting campaign expenses in violation of federal finance laws. As a private citizen I am requesting that the Federal Election Commission conduct an investigation into these illegal actions.

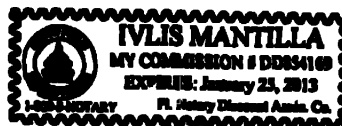

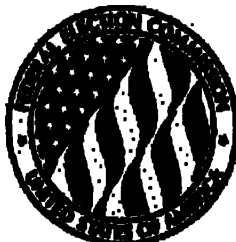

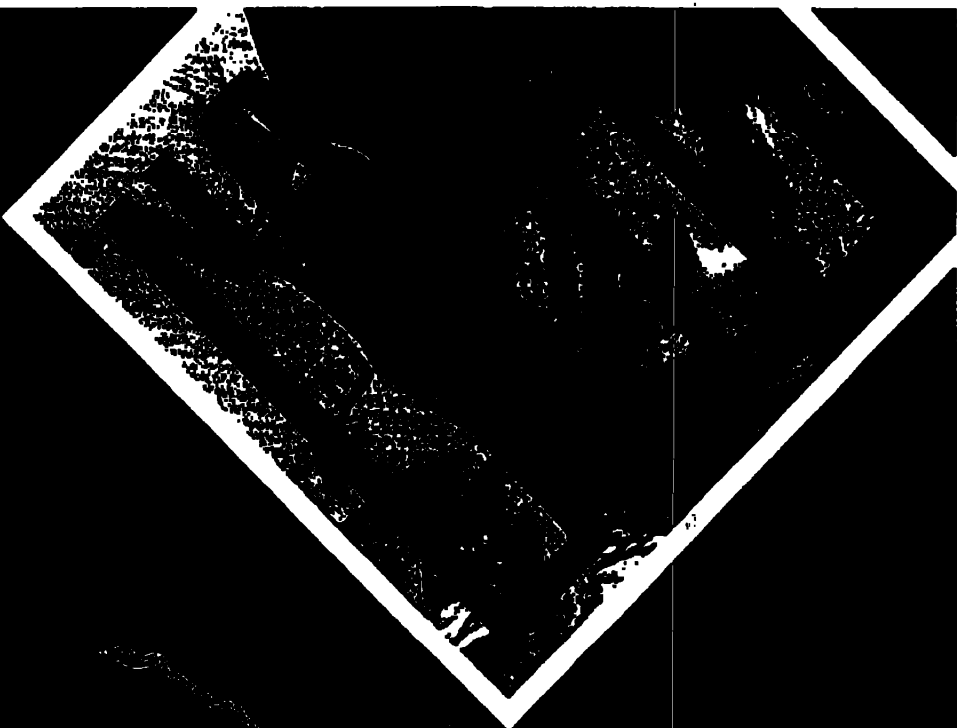
