Dear Mr. Jordan:

We represent the Picayune Rancheria of the Chukchansi Indians ("Tribe"), identified as the Chukchansi Tribal Government in a submission to the Federal Election Commission ("Commission"), and Californians for Fiscally Conservative Leadership ("CFCL") (collectively "Respondents") in the above captioned MUR. Our clients received copies of a complaint filed by Tal Cloud and Mike Der Manuel Jr. ("Complaint") on September 14 and September 16, 2010.

As will be detailed below, the Complaint is based upon inaccurate information. ~~Respondents have not engaged in activities in violation of the Federal Election Campaign Act~~ ("Act"). Therefore, the Commission should find no reason to believe that any Respondent violated the Act and close the file as it pertains to this matter.

THE COMPLAINT

The Complaint alleges that that Respondents violated 11 CFR sections 104.5(g)(2) and 104.4(c) because they have failed to file "reports with the FEC detailing the independent expenditure" after airing television and radio ads featuring Jeff Denham. The Complaint also alleges, in the vaguest of possible terms, that the "egregiousness of this violation is magnified by questions surrounding the source of funds used to pay for the independent expenditure. A recent Fresno Bee story details a leaked tribal document which indicates that the Tribe held a benefit concert to 'raise funds for Jeff Denham's campaign.'"

THE RESPONDENTS

The Picayune Rancheria of the Chukchansi Indians is a federally recognized Indian tribe. Its territory comprises federal Indian reservation lands known as the Picayune Rancheria located

near the town of Coarsegold in Madera County, California. The Tribe owns and operates a casino, hotel and resort complex, the Chukchansi Gold Resort and Casino (Casino), on lands it owns within the boundaries of the Picayune Rancheria. The governing body of the Picayune Rancheria of the Chukchansi Indians is its Tribal Council - comprised of seven tribal members elected by the general council of the Tribe pursuant to the Constitution of the Picayune Rancheria of the Chukchansi Indians.

CFCL is a tax exempt political organization under section 527 of the Internal Revenue Code registered with the Federal Election Commission. CFCL is an independent expenditure only committee and does not make contributions to candidates for federal office or other federal political committees. CFCL is not affiliated with any other political committee that makes contributions within the meaning of the Act.

THE LAW

Under Commission regulations, a public communication is any communication by means of any broadcast, cable or satellite communication, newspaper, magazine, outdoor advertising facility, mass mailing or telephone bank to the general public, or any other form of general public *political* advertising. 11 CFR § 100.26 (emphasis added). A public communication is deemed coordinated and constitutes an in-kind contribution if the following three-prong test is satisfied: (1) the communication is paid for by someone other than a candidate, the candidate's authorized committee or an agent of either; (2) the communication satisfies one of the content standards set forth in 11 C.F.R. § 109.21(c); and (3) the communication satisfies one of the conduct standards set forth in 11 C.F.R. § 109.21(d). Therefore, a communication which lacks political advertising and which does not satisfy the three prong coordination test, by definition cannot be a coordinated communication such that a contribution results.

Prior to the United States Supreme Court's holding in *Citizens United v. FEC* that corporations may make unlimited independent expenditures using corporate treasury funds, corporations were generally prohibited from making a contribution or expenditure in connection with any election. 2 U.S.C. § 441b. While corporations are still prohibited from using general treasury funds to make contributions to candidates and political committees, the Supreme Court's holding in *Citizens United* makes it clear that independent corporate political spending cannot be limited. See *Citizens United v. FEC*, 130 S. Ct. 876, 913 (2010).

In accordance with the Supreme Court's ruling in *Citizens United* and holdings in *SpeechNow.org v. FEC* and *EMILY's LIST v. FEC*, the Federal Election Commission (FEC) concluded in Advisory Opinion 2010-11 that an independent expenditure-only committee that registers as a nonconnected political committee and reports with the FEC can solicit and accept

unlimited contributions from individuals, political committees, corporations and labor organizations for the purpose of making independent expenditures. See Advisory Opinion 2010-11.

Under the Act, an independent expenditure is an "expenditure by a person that expressly advocates the election or defeat of a clearly identified candidate and that is not made in concert, in consultation or cooperation with or at the request or suggestion of the candidate, the candidate's authorized political committee, a political party committee or the agents of any of the foregoing." 2 U.S.C. 431(17). A communication which is made in cooperation, consultation, or concert with, or at the request or suggestion of, a candidate, a candidate's authorized committee or other agents, is a coordinated communication under 11 CFR § 109.21.

Commission regulations at 11 CFR § 104.4 require that every political committee that makes independent expenditures must report all such independent expenditures on Schedule E. For independent expenditures made at any time up to and including the 20th day before an election aggregating \$10,000 or more in a calendar year, political committees must file necessary reports on the second day following the date on which a communication that constitutes an independent expenditure is publicly distributed or otherwise publicly disseminated ("48 Hour Reports"). Independent expenditures aggregating \$1,000 or more with respect to a given election that are made after the 20th day, but more than 24 hours before the day of the election must be reported the day following the date on which a communication is publicly distributed or otherwise publicly disseminated ("24-Hour Reports").

DISCUSSION

There is No Reason to Believe a Violation Occurred Based Upon the Allegations in the Complaint.

The Complaint's failure to state exactly which advertisements are in alleged violation of the Act has put Respondents in the awkward position of having to guess whether Complainants believe the advertising of the Charity Event is problematic, the independent expenditure ads are problematic, or both. By not being specific in its allegations, a burden required of a Complainant, Respondents are tasked with trying to guess as to which activity by which Respondent should be addressed.

The Complaint makes allegations against both the Tribe and CFCL. Although the Complaint lacks any specificity as to which Respondent allegedly did what, it appears that there

is one set of allegations surrounding a charity concert and a second set of allegations with regard to communications made at a later time.

First, the Complaint alleges that the Tribe made certain expenditures in connection with an event held at its casino—a country and western charity benefit concert related to Project Gold Star, a program of the California Department of Veterans Affairs—constituting contributions, in-kind or otherwise, to the Jeff Denham campaign. The Complaint relies heavily on a “tribal document which indicates that the Tribe held a benefit concert to ‘raise funds for Jeff Denham’s campaign.’” As will be discussed further, the concert held at the Tribe’s casino was not, in fact, a fundraiser for Jeff Denham’s campaign but rather a charity concert and expenditures made by the Tribe in connection with the event do not constitute contributions under the Act.

Second, the Complaint alleges that CFCL made communications within 30 days of a primary election which necessitated disclosure to the Federal Election Commission. Contrary to the allegations that CFCL failed to “file reports with the FEC detailing the independent expenditure,” CFCL did, in fact, register and file disclosure with the FEC regarding the communications aired in the days prior to the primary election.

a. Allegations against the Tribe concerning the charity concert

The Chukchausi Gold Resort and Casino (Casino) served as the venue for a charity event to benefit the California Department of Veterans Affairs Project Gold Star (Charity Concert). The event held on May 28, 2010, was organized by the Remembering the Brave Foundation (Foundation), a 501(c)(3) organization, and featured a concert by Phil Vassar, an American country music star. See www.RememberingTheBrave.org.

The Complaint alleges that Respondents aired television and radio ads and made other expenditures featuring Jeff Denham within thirty days of a primary election. While CFCL did make, and properly report, certain independent expenditures, it is important to distinguish between expenditures made by the Tribe in connection with the Charity Concert held at the Casino and those expenditures made by CFCL. In fact, CFCL was not formed until after the Charity Concert and had no involvement with the Charity Concert.

The Complaint alleges that advertisements promoting the Charity Concert included images of Jeff Denham and were paid for by the Tribe and coordinated with the Jeff Denham campaign. There is no factual basis for these allegations. In promoting the event, the Tribe made the following in-kind donations:

- The Chukchansi Gold Resort and Casino Half Dome Events center as the venue for the concert; See TR_CFCL_FEC 0000058-0000075 (Agreement between Remembering the Brave and Phil Vassar) and TR_CFCL_FEC 0000029-0000034 (Draft Agreement for Half Dome Use)
- A strip ad with the Fresno Bee; See TR_CFCL_FEC 0000042
- Rack cards for distribution; See TR_CFCL_FEC 0000046
- Postcards for distribution to Chukchansi guests; See TR_CFCL_FEC 0000047
- Automated phone calls to Chukchansi guests; See TR_CFCL_FEC 0000035-0000036
- Food vouchers with the purchase of two tickets to the event;
- Rooms and meals for performers;
- Email blast; See TR_CFCL_FEC 0000041
- Poster; See TR_CFCL_FEC 0000043
- Casino overhead announcements. See TR_CFCL_FEC 0000044-0000045.

Additionally, several television and radio stations ran PSAs promoting the event which were provided without cost to the Tribe. See TR_CFCL_FEC 0000044-0000045. The Tribe did not pay for or distribute any promotional materials featuring Jeff Denham. Rather, the Tribe's promotional materials merely promoted the Charity Concert and did not refer to a clearly identified candidate, did not disseminate campaign materials prepared by a candidate, and did not expressly advocate the election or defeat of a clearly identified federal candidate. The advertisements promoted the Charity Concert—not Jeff Denham's campaign—and were not political advertising subject to the Act.

The Complaint does not specifically allege or provide any factual information upon which to find that the Tribe acted in violation of the Act with regard to the Charity Concert. The Complaint alleges that ads were run featuring Jeff Denham and also alleges these ads were coordinated. However, advertising paid for by the Tribe to promote the Charity Concert made no mention of Jeff Denham at all. Given the information available, there is no factual or legal support for finding that the Tribe made coordinated communications or acted in violation of the Act.

The Complaint also alleges that the Charity Concert was a fundraiser for Jeff Denham. As previously discussed, the event raised funds to benefit the California Department of Veterans Affairs Project Gold Star—not the Denham campaign. The Complaint submitted a rough draft of minutes taken during a Chukchansi Marketing Department meeting which contained an erroneous characterization of the Charity Concert. Final minutes of the meeting are attached as TR_CFCL_FEC 0000038-0000040. The materials provided clearly show that the event was a charitable event and not a fundraiser for the Denham campaign.

b. Allegations against CFCL regarding independent expenditures

The Complaint alleges that CFCL “aired television and radio ads and made other expenditures featuring Jeff Denham within thirty days of a primary election to the U.S. Congress without complying with disclosure requirements under federal law.” The Complaint also alleges that there was coordination between CFCL and the Denham campaign. Both of these allegations are false.

CFCL did make independent expenditures in the form of radio advertisements in the days prior to the California primary. These expenditures were separate from, and after, the Charity Concert discussed previously.

CFCL’s activities are materially indistinguishable from those of Commonsense Ten in Advisory Opinion 2010-11 which concluded that “corporations, labor organizations, and political committees may make unlimited independent expenditures from their own funds, and individuals may pool unlimited funds in an independent expenditure-only political committee.” Like Commonsense Ten, CFCL was formed as a non-unionized political committee and registered with the Commission on June 3, 2010. See TR_CFCL_FEC 0000025-0000028. In addition to filing its Statement of Organization, CFCL also filed a letter with the Commission clarifying that it intended to accept unlimited contributions for the purpose of making independent expenditures as recommended in Advisory Opinion 2010-11 fn 4. See TR_CFCL_FEC 0000005. CFCL has also filed reports required under sections 432, 433, and 434 of the Act and accompanying regulations disclosing the receipt of contributions and expenditures made. See TR_CFCL_FEC 0000001-0000004, TR_CFCL_FEC 0000006-0000014, and TR_CFCL_FEC 0000017. Similar to Commonsense Ten, CFCL does not make contributions and is an independent expenditure-only political committee. As disclosures to the FEC reveal, CFCL has solicited and accepted funds from two sources, the Pechanga Band of Luiseno Indians and the Chukchansi Economic Development Authority.

Although the Complaint does not allege with specificity which communications are allegedly coordinated with Jeff Denham, the communications disclosed on CFCL’s independent

expenditure report filed on June 4, 2010 were not coordinated with the Denham campaign; the ads do not republish campaign materials prepared by the candidate or his campaign; the ads were not created, produced or distributed at the request or suggestion of the candidate or his campaign; information contained in the ads was obtained from publicly available sources such as newspapers and the Internet; neither the candidate nor the campaign were materially involved in decisions regarding the ads; and there was not substantial discussion between the candidate and the campaign and CFCL. The scripts are attached as TR_CFCL_FEC 0000037.

Conclusion

In light of the speculative nature of the allegations and the lack of factual information to substantiate the claims, there is no support for finding that the Tribe made expenditures referencing Jeff Denham in connection with the Charity Concert held at the Casino. Nor is there support for finding that CFCL coordinated their communications with Jeff Denham or that they failed to report independent expenditures. In its Statement of Reasons in MUR 4960, the Commission stated that "[u]bsent personal knowledge, the Complainant, at a minimum, should have made a sufficiently specific allegation...so as to warrant a focused investigation that can prove or disprove the charge." In the Statement of Reasons issued for MUR 5141, the Commission stated that "[u]nwarranted legal conclusions from asserted facts or mere speculation...will not be accepted as true....A complaint may be dismissed if it consists of factual allegations that are refuted by sufficiently compelling evidence produced in responses to the complaint. As per the Commission's own standards, there is not a sufficient basis upon which to recommend a finding of reason to believe that Respondents violated the Act. The Complaint has failed to provide "sufficiently specific allegations" warranting an investigation and Respondents have made a good faith effort to attempt to identify activities that are perhaps contemplated by the Complaint. The factual record refutes the allegations with sufficiently compelling evidence. Therefore, Respondents respectfully request that the Commission find no reason to believe that violations of the Act have occurred and dismiss the matter against both Respondents.


