
This is a response to the above referenced MUR received by this organization dated September 7, 2010, which contains two complaints.

The first complaint is a violation of Chapter 10, Section 2 of the FEC Guideline Book as it relates to the disclaimer being contained within a specific printed box. While the disclaimer in question was not contained within a printed box, it was very conspicuous. The disclaimer was printed with high level of color contrast and was bigger than required and quite easily noticed. These large campaign signs were the first items designed by the grassroots campaign and the box was inadvertently omitted. All of the other campaign literature contained the box required by the Guidelines. In addition, since Mr. Sager lost the primary election, all of the signs have been removed and are no longer in use.

The second complaint was not filing the Pre-Primary report by the due date of August 12, 2010. Enclosed is the notice dated August 13, 2010, requesting that this report be filed within four business days. Also enclosed is a copy of the signature page for this report which shows the campaign electronically filed this report on August 16, 2010 in accordance with the notice.

We trust that this will resolve this MUR, but if you need further information, please let us know.
