**Complaint of Darren Tobolt against Collett for Congress (HOMN04148),
Fred Meyer, Treasurer and Teresa Collett**

Dear Sir or Madam,

I represent Darren Tobolt, a citizen of and registered voter in the 4th Congressional District of Minnesota. His address is _____ St. Paul, Minnesota 55102.

My client hereby submits this complaint (original and 3 copies) against Teresa Collett, Republican candidate for the United States House of Representatives for the Fourth Congressional District of Minnesota, Collett for Congress (her principal campaign committee), and Fred Meyer, its treasurer, Respondents. Because of the extensive and repeated violations of law committed by Ms. Collett and her principal campaign committee, my client requests expedited consideration of this complaint.

The clear violations to date are:

First, failure to file a Statement of Organization in the timely manner required by 2 U.S.C. § 432 and 433. Attached are sample copies of some of Ms. Collett's Facebook and website statements and campaign activities for the period of January 30 to May 25, 2010, showing her 2010 actions as a candidate.

However, FEC records show that candidate Collett did not file her Statement of Organization until April 20, 2010 and did not file a completed and accurate Statement of Organization until August 17, 2010. My client requests that an investigation be commenced and that Respondent be fined for such a clear and flagrant violation of law.

First Quarter contributions to Collett for Congress were \$6,157.00 and First Quarter Disbursements were \$1,045.35. This leaves a net on hand of \$5,111.65 which is the precise amount shown on the July 15 Report and is in excess of the \$5,000 statutory reporting threshold.

In addition, there appears to have been a disbursement of an additional \$1,508 that was incurred by individuals or on a credit card, but paid in the second quarter.

Please also note that during the first quarter of 2010, Ms. Collett received contributions of at least \$6,157, but did not timely report the same. Indeed, the filings to date, as shown on the Second Quarter report, still do not show the unreported first quarter activities.

Second, the FEC website as of August 20, 2010 shows a failure by candidate Collett and her committee to file the required First Quarter Report at all.

Third, the FEC website as of August 20, 2010 shows that candidate Collett still has not filed her Statement of Candidacy (FEC Form 2).

Fourth, other deficiencies are:


1. Failure to disclose full information on contributors. Of 35 itemized individuals, Respondents failed to completely identify 16 contributors, (46%). 2 U.S.C. § 432.
2. Failure to disclose the true and complete purpose of disbursements to individuals and vendors:

--Patrick Davis, Jih Vujovich and Susan Smith are listed vaguely as consulting fees.

--Vendors Service Plus, Council for National Policy, and several reimbursements to individuals are inadequately described merely as "supplies" and "convention."

All of the foregoing facts are ascertained from the FEC website and/or other public websites.

Based on the above flagrant violations of elementary FEC reporting and disclosure requirements, Ms. Collett's campaign committee and its Treasurer should be fined as required by law.

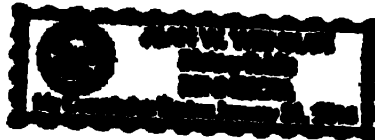

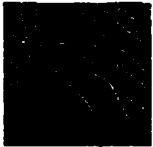

In addition, this Statement must be signed and dated by the committee treasurer or his/her designated agent. A copy of FEC FORM 1 can be downloaded from the FEC website at <http://www.fec.gov>, or requested through the FEC Faxline at (202) 501-3413.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.
