This letter is to inform the Office of General Counsel of a possible FEC violation related to the under reporting of campaign debt by the Len Britton for Vermont campaign. We previously sent a letter dated August 30, 2010 to the Secretary of the Senate reporting this matter in the hopes of an amicable resolution. Len Britton and his campaign have continually avoided settling this outstanding debt. We are lodging a formal complaint with you at this time. Additionally, neither Len Britton nor his campaign has made a payment on this account in over 100 days.

Complaint:

The Len Britton for Vermont campaign has understated the amount owed to Castle Management Group LLC for campaign management/consulting services. In both the 2010 second quarter filing and the 2010 pre-primary filings, the Len Britton for Vermont filings incorrectly state the outstanding balance due to Castle Management Group LLC is \$16,577.54. The correct balance as of June 16, 2010 is \$44,196.17.

Facts to support the complaint:

1. The account statement and corresponding email we sent to the candidate and campaign treasurer which reflected the correct balance of \$44,196.17 on June 16, 2010; and
2. The letter we sent to the campaign advising them of the under reporting of campaign debt on August 20, 2010 to which we received no response.




