Enclosed please find an original and three copies of my notarized Complaint in this matter, including Exhibit A. The Complaint alleges a violation of the FEC's "\$5000" maximum contribution per election rule.

One thing that amazes me is that the FEC does not automatically and electronically pick up an obvious violation of its own rules when the contributions are uploaded onto www.FEC.GOV. And what should amaze the People of the United States is that the FEC was given no power from Congress to prevent Experian from contributing **anything** to the campaign of Mr. Stearns. Mr. Stearns sits on the House Sub Committee on Telecommunications and the Internet which regulates the activities of Experian. Any contribution by Experian to Stearns is a fundamental conflict of interest for Experian to give and for Stearns to accept.


COMPLAINT

1. Complainant is a candidate for the U.S. House of Representatives, Florida District 06 in the November 2, 2010 election.
2. Respondent EXPERIAN NORTH AMERICA INC., PAC, (hereafter referred to as "Experian") is a political action committee registered with the Federal Election Commission.
3. Respondent Stearns is Complainant's opponent in the November election for Mr. Stearns' Florida District 06 House seat.
3. Experian made 4 contributions in 2010 which total \$13,000 to Respondent Stearns' "Friends of Cliff Stearns" principle campaign committee according to the FEC.gov website.
(See Exhibit A attached hereto.)
4. These contributions are illegal and in excess of that permitted by the FEC.

WHEREFORE, Complainant asks that the FEC take enforcement action against respondents pursuant to 2 U.S.C. § 437g.

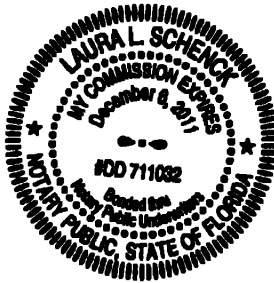
