Dear Mr. Jordan:

This response is submitted by undersigned counsel on behalf of Experian North America, Inc. Political Action Committee ("Experian PAC") in reply to the complaint designated as Matter Under Review 6389. In summary, there is simply no basis to the assertion raised in the complaint filed by Mr. Schonberg that the Experian PAC contributed in excess of permitted limits to the Friends of Cliff Stearns campaign committee, and accordingly, respondents request that the Commission dismiss this action by finding no Reason to Believe that a violation of the Federal Election Campaign Act ("FECA") has occurred.

Mr. Schonberg's complaint, received by Experian PAC on October 7, 2010 asserts that Experian PAC made contributions totaling \$13,000 to Friends of Cliff Stearns. Quite to the contrary, and as demonstrated in the contribution reports filed by both Experian PAC and the Friends of Cliff Stearns Committee, the total amount contributed this election cycle to date is \$6,500, fully compliant with the contribution limits established in FECA.

Contribution History

Experian PAC is the connected committee of Experian North America, Inc., and is registered with the Federal Election Commission ("FEC") as a multicandidate committee. As such, Experian PAC is permitted to contribute up to \$5,000 per election to the principal campaign committee of a candidate for federal office. 2 USC 441a(a)(2), 11 CFR 110.2. In the current election cycle that commenced on January 1, 2009, Experian PAC has contributed a total of \$6,500 to Friends of Cliff Stearns as follows:

- \$5,000 via check #1501 and dated March 25, 2010, designated to the primary election; and
- \$1,500 via check #1514 and dated April 21, 2010, designated to the general election.

Copies of these checks are enclosed as Exhibit A. Of note, these checks designate a specific election for each contribution, reflecting existing processes utilized by Experian PAC to ensure that contributions are properly designated and meet established limits. These contributions were reported on Experian PAC's April Monthly 3X and May Monthly 3X reports, respectively.¹ Copies of the relevant pages of these reports are enclosed as Exhibit B.

These same contributions were also recorded as designated on the April Quarterly 3X and July Quarterly reports, respectively, filed by Friends of Cliff Stearns. Copies of the relevant pages of the reports filed by Friends of Cliff Stearns are enclosed as Exhibit C. Moreover, a standard search of the FEC contribution database identified no other contributions made by Experian PAC to Friends of Cliff Stearns, and indeed none were made. The search results are enclosed as Exhibit D.

The complaint filed by Mr. Schenberg is entirely baseless, and represents little more than a political stunt designed to attract attention to his ongoing vendetta against the FEC. Beyond the obvious factual inaccuracy of the complaint, Mr. Schenberg's motivations are made even more apparent by the press release issued by Mr. Schenberg on October 3, 2010 highlighting his complaint, as well as his lawsuit seeking to abolish the FEC as unconstitutional (attached as Exhibit E).

For the reasons outlined in this response, Respondent Experian PAC requests that the Commission dismiss the complaint and find no Reason to Believe that Experian PAC violated the Federal Election Campaign Act.

CANDIDATE and FEC at ODDS AGAIN

- SCHONBERG FILES NEW COMPLAINT RE STEARNS' FUNDRAISING
- ARGUES FEC IS INEPT

OCALA, FL – Steve Schonberg, candidate for the U.S. House, FL-06, hand-delivered a Complaint to the Federal Election Commission on Friday alleging that his opponent, incumbent Cliff Stearns, was “in violation of the FEC’s ‘\$5000’ maximum contribution per election rule.” The Complaint pointed out that a political action committee for the credit reporting corporation Experian North America, Inc., had made \$13,000 in contributions to Stearns in 2010.

Schonberg expressed amazement “that the FEC does not automatically and electronically pick up an obvious violation of its own rules...” He also contended that what should amaze the “People of the United States is that the FEC was given no power from Congress to prevent Experian from contributing **anything** to the campaign of Mr. Stearns,” because Stearns sits on the House Sub Committee on Telecommunications and the Internet which regulates Experian’s activities. Schonberg asserted that, “Any contribution by Experian to Stearns is a fundamental conflict of interest for Experian to give and for Stearns to accept.” Date-stamped copies of the original documents are posted at: <http://schenbergforcongress.com/FEC10-1-10.pdf>.

Schenberg believes he is the only candidate for the House whose platform includes doing away with the FEC; and his campaign to unseat Stearns was begun only after Schonberg had already filed suit in Federal Court in Ocala alleging that the FEC was unconstitutional.
