lack the disclaimer of "Paid for by the Nebraska Republican Party and not authorized by any candidate or candidate's committee" as required by the FEC on bulk electronic email (defined as electronic mail with more than 500 substantially similar communications.)

Several of these emails also urge action to volunteer to help the campaign of a federal candidate, or they invite guests to a fundraiser featuring a federal candidate, or solicit funds for a federal committee. These emails also lack the disclaimer as required for a communication that solicits funds for a federal candidate or a federal political committee or that contains express advocacy.

However, the emails sent on:

- Wed, May 12, 2010
- Friday, June 25, 2010

do close with the required disclaimer of "Paid for by the Nebraska Republican Party and not authorized by any candidate or candidate's committee." So it would appear that the email blast software ("Constant Contact") used by the Nebraska Republican Party is capable of placing a disclaimer at the bottom of the email, but the Nebraska Republican Party does not place the disclaimer on all emails.


