General Counsel Hughey:

This complaint alleges violations of the Federal Election Campaign Act of 1971, as amended (the "Act") by Adler for Congress and Peter DeStefano for Congress, the principal campaign accounts of Congressman John Adler and Peter DeStefano. Additionally, this complaint alleges violations of the Federal Election Campaign Act of 1971 by the Camden County Democratic Committee, a county political party committee registered with the New Jersey Election Law Enforcement Commission. Specifically, this complaint summarizes the available facts which when viewed objectively, demand that the Commission investigate Respondents' election-related activities to determine the extent of their violations of the Act. 2 U.S.C. § 431 *et seq.*

Background

Adler for Congress ("Adler") is the principal campaign account of Congressman John Adler, the Democrat Party's nominee for the House of Representatives in the 3rd Congressional District of New Jersey. The address for Adler for Congress is 14 Knightswood Drive, Marlton, NJ 08053. Peter DeStefano for Congress ("DeStefano") is the principal campaign account of Peter DeStefano who is running for the House of Representatives in the 3rd Congressional District of New Jersey under the slogan "NJ Tea Party." The address of Peter DeStefano for Congress is P.O. Box 576, Lumberton, NJ 08048. The Camden County Democratic Committee (the "CCDC") is a county political party committee registered with the New Jersey Election Law Enforcement Commission ("ELEC"). The address of the Camden County Democratic Committee 2240-15 Route 70 West, Cherry Hill, NJ 08002.

Facts

November 2, 2010 is the general election date in the State of New Jersey. The office of Member of the House of Representatives for the 3rd Congressional District is on the November 2nd ballot. Congressman

John Adler is the Democrat nominee for that office. Peter DeStefano is a candidate for that office by virtue of the filing of a petition for direct nomination on June 8, 2010. Mr. DeStefano is running under the slogan "NJ Tea Party."

Based upon published news reports, DeStefano has received support directly from staff members and consultants paid for by Adler and the CCDC. See Exhibits 1 and 2. According to published news reports, Steve Ayscue ("Ayscue") and Geoff Mackler ("Mackler") led a meeting in May of 2010 to solicit organizational and operational support for DeStefano. Id. This support, according to the article, included organizing the solicitation of signatures on Peter DeStefano's petition by direct nomination to appear as a candidate for the 3rd Congressional District of New Jersey in November. Id. In addition to Ayscue and Mackler, the story contends that Matt White and Bill Moen were participants in the solicitation of signatures for Peter DeStefano. Id. In addition to the foregoing, at least one article reports that Ayscue operates the campaign website, Twitter account and Facebook page of DeStefano. Id.

Information readily available on the internet identifies Steve Ayscue as the owner of Haddon Capital Ventures, LLC located in Haddon Heights, NJ. See Exhibit 3. Haddon Capital Ventures is a paid consultant of Adler. See Exhibits 4 and 5. Adler paid Haddon Capital Ventures \$5000 on three separate occasions, 4/6/2010, 5/21/2010 and 6/10/2010. Id. These payments were made both in advance of and following the May meeting described in the news reports where Ayscue solicited organizational and operational support for DeStefano. Id.

Information readily available on the internet indicates that Geoff Mackler is an employee of Adler. See Exhibits 4 and 5. Those documents appear to show that Mackler has been paid thousands of dollars monthly by Adler. Id. These payments were made both in advance of and following the May meeting described in news reports where Mackler solicited organizational and operational support for DeStefano. Id.

Information readily available on the internet indicates that Matt White and Bill Moen are employees of the CCDC. See Exhibit 6. Those documents appear to show that they have been on the CCDC payroll since prior to the May meeting described in the news reports and continued as employees in the months after the May meeting. Id. Both were on the CCDC payroll at the time signatures were being solicited for DeStefano's petition by direct nomination. Id.

Upon information and belief, the CCDC is not registered with the FEC. The CCDC did not report to ELEC any portion of the salaries of White or Moen as contributions to Adler or DeStefano. See Exhibit 6.

Upon information and belief, Adler has not reported receipt of any in-kind contributions from the CCDC for the current election cycle.

Upon information and belief, Adler has not reported any in-kind contribution to DeStefano.

Information readily available on the internet shows that DeStefano filed a Statement of Candidacy on July 13, 2010 with the FEC, more than 30 days after he became a candidate under New Jersey law. See Exhibit 7. Additional documents appear to show that DeStefano filed an incomplete Statement of Organization with the FEC on August 30, 2010. See Exhibit 8. The FEC advised DeStefano that the Statement of Organization was incomplete on September 16, 2010. See Exhibit 9. Upon information and belief, to date, DeStefano has not properly filed a complete Statement of Organization with the FEC. Upon information and belief, DeStefano has not filed any report of his receipts or expenditures with the FEC. Upon information and belief, DeStefano has not reported the receipt of any in-kind contribution from Adler. Upon information and belief, DeStefano has not reported the receipt of any in-kind contribution from the CCDC.

Analysis

A "contribution" is defined by the Act to include "the payment by any person of compensation for the personal services of another person which are rendered to a political committee without charge for any purpose," 2 U.S.C. §431(8).

Upon information and belief, based upon the foregoing recitation of the facts and news reports, Adler compensated Ayscue and Mackler in connection with their work seeking organizational and operational support for DeStefano. Macker was compensated directly by Adler and Ayscue was compensated in his role as the owner of Haddon Capital. Furthermore, upon information and belief, Ayscue and/or Mackler did additional work for DeStefano including, at a minimum, operating and maintaining DeStefano's website, Twitter account and Facebook page. Should your investigation reveal the facts and news reports accurately describe the work performed for the benefit of DeStefano or that additional work for DeStefano was performed by Ayscue and Mackler, Adler's compensation of Ayscue and Mackler constitutes a "contribution" to DeStefano. Upon information and belief, any "contribution" to DeStefano resulting from Adler's compensation of Ayscue and Mackler is in excess of the \$2000 contribution limit applicable to Adler and thus, unlawful. 2 U.S.C. §432(e)(3)(B). Moreover, any "contribution" to DeStefano by Adler is required to be reported by Adler to the FEC. In this instance, Adler has not reported any contribution to DeStefano.

Upon information and belief, based upon the foregoing recitation of the facts and news reports, the CCDC compensated White and Moen in connection with their efforts on behalf of DeStefano and his petition drive. Should your investigation reveal the facts and news reports accurately describe the work performed for the benefit of DeStefano or that additional work for DeStefano was performed by White and Moen, the CCDC's compensation of White and Moen constitutes a "contribution" to DeStefano. Upon information and belief, any "contribution" to DeStefano resulting from the CCDC's compensation

of White and Moen is in excess of the \$5000 contribution limit applicable to the CCDC. In addition, a contribution of \$5000 would require that the CCDC register with the FEC and file reports in accordance with the FEC's regulations. To date, the CCDC has not registered with the FEC and has not filed any reports detailing the "contributions" to DeStefano. It is also worth noting that the CCDC failed to disclose any contributions to DeStefano to ELEC in accordance with its obligations under New Jersey law.


Upon information and belief, based upon the foregoing recitation of the facts and news reports, DeStefano accepted "contributions" from Adler and the CCDC in amounts in excess of the applicable contribution limits. Further, should your investigation reveal the facts and news reports accurately describe the work performed by Ayscue, Meckler, White and Moen, it is inconceivable that DeStefano did not knowingly accept these excessive "contributions." That DeStefano has, upon information and belief, failed to report any of these "contributions" also warrants investigation.

Relief Sought

Based on the foregoing information, there is ample evidence to support a Federal Election Commission investigation into whether: (1) Adler has made in-kind contributions to DeStefano which were not reported by Adler and which were in excess of the legal contribution limits; (2) the CCDC has made in-kind contributions to DeStefano in an amount which requires the CCDC to register with and report to the Federal Elections Commission; (3) the CCDC has made in-kind contributions to DeStefano which were not reported and which were in excess of the legal contribution limits; (4) DeStefano has received in-kind contributions from Adler and the CCDC in excess of the legal contribution limits; (5) whether DeStefano has failed to report contributions from Adler and the CCDC; and (6) Adler, the CCDC and DeStefano coordinated their activities with the purpose of circumventing the contribution limits set forth in 2 U.S.C. §432.



On a balmy evening last May, about three dozen members of the South Jersey Young Democrats convened at the Camden County Democratic Committee Headquarters in Cherry Hill.

Freeholder Jeffrey Nash warned the assembled crowd of party volunteers and legislative aides that the sour economy would make the coming election season difficult for the Democratic majority.

He told the young activists they had to get out the vote for Democrats in the fall.

Then Steve Ayscue — a paid CCDC consultant — took the floor with a bearded, flame-haired man few had seen before. The latter was Gabe Mackler, dispatched from the Democratic Congressional Campaign Committee to lead freshman Rep. John Adler's re-election campaign.

Ayscue and Mackler had a plan to ensure Adler's victory. They just needed volunteers.

Internal numbers-crunching showed the difference between Adler and his Republican opponent — then undetermined — would hover around 5 percent. To give Adler an edge, Ayscue had recruited a then-unknown man to run as a third-

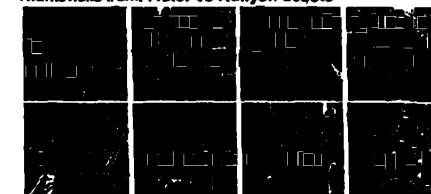

That candidate would act as a conservative spoiler to confuse voters and pull votes from Adler's eventual Republican challenger. But first he has to get on the ballot. With the filing deadline just weeks away, CCDC needed volunteers to hit the streets and collect signatures — fast.

Some of the SJYD members were stunned. Others willingly signed on.

By June 8, more than the 100 valid signatures needed were collected and received by the state Division of Elections.

That candidate was Peter DeStefano, a picture framer from Mount Laurel. On Nov. 2, he will appear on the "NJ Tea Party" line on the ballot.

Requests to speak with Meckler, Ajazue, and CCDC co-chairs James Beach and Donald Norcross were denied or not returned. Beach only agreed to respond to questions via e-mail.

The 6th legislative district senator did not directly answer the questions. Instead, through CCDC spokesman Tom Turcol, he wrote, "This party's primary mission is to elect the best possible candidates for public office, and it conducts itself in a manner that is completely above-board and in full accordance with the law."
