Attached you will find a copy of the donation made by TransCanada Keystone Pipeline to the Bruning for Attorney General Committee. The donation of \$2,500 was reported to Nebraska Accountability and Disclosure on 01/22/2010. On the Campaign Statement, filed with Nebraska Accountability and Disclosure on 04/12/2010, the \$2,500 donation from TransCanada Keystone Pipeline to the Bruning for Attorney General Committee is listed with no street address to show the origin of the donation thus obscuring the original source of the corporate donation. Did the donation actually come from the corporate office of TransCanada Energy, Ltd. in Calgary, Alberta, Canada?

From FEC 110.20. Foreign nationals are prohibited from making contributions, donations or expenditures in connection with any election—federal, state or local. Also, foreign nationals may not donate to any party committee building fund or fund electioneering communications

Definition of Foreign National The following entities are considered foreign nationals and are therefore subject to the prohibition: foreign governments, foreign political parties, foreign corporations, foreign associations, foreign partnerships....

TransCanada Energy, Ltd is a foreign corporation headquartered in Calgary, Alberta, Canada.

I ask that you kindly investigate if the Bruning for Attorney General Committee violated FEC regulations by accepting a donation from a Foreign National.


