Dear Mr. Jordan:

On behalf of respondent Communications Workers of America Working Voices ("CWA WV"), I am writing to request an enlargement of time to respond to the complaint, from November 20 (15 days after CWA WV received your letter) to December 20, for the following reasons. First, key personnel who were involved with CWA WV during the period described in the complaint have been traveling out of the country and will not return until later this week. Second, although the complaint makes no allegations specific to CWA WV and relies wholly on a circumstantial sequence of alleged events, we wish to review the relevant facts and circumstances carefully so as to provide as full and accurate a response as is warranted. Third, inasmuch as the period covered by the complaint is very recent and there are at least 27 respondents, the brief enlargement of time requested by CWA WV will not prejudice the Commission's ability to adequately consider whether or not to find reason to believe that CWA WV violated the Federal Election Campaign Act.

We also note that both the complaint and your letter misstate CWA WV's name, which includes the word "America," not the word "American", as CWA WV's registration with the Commission will confirm. Kindly adjust your records in this matter accordingly.
