Dear Mr. Jordan:

I am the Solicitor for the Republican Committee of Chester County ("RCCC" or "County Party") and I write in response to your letter of November 4, 2010.

It is our understanding that the circumstances referenced in your letter did not in fact give rise to the need to register, and consequently there was no need to report. I wanted to clarify that the subject videos were actually produced by a volunteer and the County Party did not pay for said videos. Consequently, we believed the posting of said videos fell within the volunteer activity on the internet exemption. What the County Party did pay for was to host a website on which the videos were displayed but that cost was only \$300.00 and thus did not approach the applicable reporting threshold.

With reference to the disclaimer, we acknowledge it may have been ambiguous or incomplete. We now recognize that such disclaimers in addition to having the "paid for" language should also have the "authorized by" language.

Future volunteers will be informed of the disclosure requirements. Please recognize that the RCCC and its volunteers did their best to comply with the complex federal election laws.



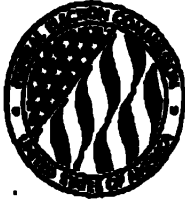
