Dear Mr. Huey:

The undersigned represents Joe Miller for US Senate, the Respondent in the above-referenced MUR, and the principal authorized committee of Joe Miller, Republican nominee for the US Senate from Alaska in the 2010 general election ("the Committee").

The Statement of Designation of Counsel was received by the undersigned on December 1, 2010. This is the response to the Complaint in the above-referenced MUR.

After reviewing the newspaper ad at issue in the complaint, it appears that the campaign volunteers who placed the ad failed to include the specific disclaimer required by the regulations of the Federal Election Commission ("the Commission" or "FEC") at 11 C.F.R. §§110.11(a)(1), (b)(1) and (c). A copy of the ad is attached to this response.

As can be seen from the ad, it clearly demonstrates that the source is the Joe Miller campaign, containing both the candidate's picture and text, the Committee's website address and phone number.

There is no text box and there is not the specific language saying "Paid for by...". However, there is no doubt as to the source of the ad as being from the Joe Miller campaign.

Further, the Committee paid for the costs of the ad in the amount of \$474.48, and the disbursement for the ad was reported on the Committee's October Quarterly FEC report, attached hereto.

The failure to include the specific disclaimer language and format described in the FEC regulations was an oversight and resulted solely from the fact that campaign volunteers were unaware of the federal regulations governing public communications by political committees.
