
I am filing a complaint against the Saint Vrain Valley Education Association (SVVEA), the SVVEA Fund-Small Donor Committee and its registered agent Jerri Modrall: 255 Weaver Park Rd., Suite 202, Longmont, CO 80501. Organized under Colorado state law as a small donor committee, the SVVEA Fund-Small Donor Committee is not registered with the Federal Election Commission. Yet the unregistered entity reported making a contribution of more than \$1,000 to a federal candidate campaign committee.

Enclosed is a copy of the SVVEA Fund-Small Donor Committee's October 18, 2010, official report of contributions and expenditures made to the Colorado Secretary of State. On Schedule B the committee reports an expenditure made on October 13, 2010, in the amount of \$2,000 to Markey for Congress—the official campaign committee of Colorado 4<sup>th</sup> District Congresswoman Betsy Markey.

Upon information and belief that the contribution was duly received after the October 13, 2010, reporting deadline, I am also filing a complaint against Markey for Congress (Committee ID: C00436063): PO Box 1333, Fort Collins, CO 80522.
