Dear Sir or Madam:

I write to notify you of what appears to be a blatant violation of the Commission's disclaimer regulations and to request that you take appropriate action. In addition, the available facts suggest a violation of the obligation for a candidate to register a principal campaign committee with the Commission within 15 days of becoming a candidate.

My name is Elizabeth Kingsley. I am a 20-year resident of Washington, DC, and my business address is 1726 M St., NW Suite 600, Washington, DC 20036.

Marjorie ("Missy") Reilly Smith is a candidate for DC's non-voting congressional Delegate. According to information obtained from the FEC web site, she first filed with the Commission on October 14, 2010. (See Attachment 1.)

Several weeks before that, Ms. Smith was handing out flyers promoting her candidacy. A sample of these was provided to me by an acquaintance who observed the candidate herself distributing the flyer on September 18, 2010. The actual flyer is enclosed as Attachment 2.

More recently, lawn signs for the Smith campaign have appeared. One of these is (or has been) located on Massachusetts Avenue, NW, in approximately the 3400 block. A picture of this sign is enclosed as Attachment 3. While I did not take this picture, I did personally observe the sign in situ and can confirm that the picture is an accurate representation. The sign appears identical on both sides. I saw this sign in place on Sunday, October 24, and had been told by an acquaintance of its presence as early as October 16.

Ms. Smith publicly announced her candidacy as early as September 14 — see enclosed article of that date. (Attachment 4). She maintains a web site at www.missysmith2010.com; a printout of the home page is enclosed as Attachment 5.

According to Commission regulations, Ms. Smith's web site, her lawn signs, and her flyers should all include an appropriate disclaimer. 11 C.F.R. § 110.11(a)(1) specifically includes "Internet websites of political committees" as requiring a disclaimer. Furthermore, lawn signs and flyers would be public communications that require a disclaimer because they fall into the




category of "general public political advertising." Ms. Smith has sufficient familiarity with the disclaimer requirements to include the proper language in her broadcast ads, which can be viewed on her web site, but apparently she has chosen to disregard that legal obligation with regard to the rest of her campaign materials.

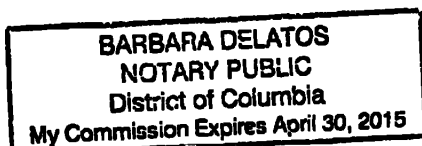
In addition to this clear and straightforward violation, the facts laid out above suggest the possibility that Ms. Smith did not register with the Commission when she should have. She announced her candidacy a month before registering. Campaign signs were printed and distributed no later than October 16. She was able to reserve air time on local television stations starting October 21, as set out on her web site. This strongly suggests that she had sufficient funding available well in advance of that date to pay for production of the ads and to book the broadcast time.

Because Ms. Smith registered the day after the close of the books for the 20-day pre-election report, it is difficult for an outside observer to determine for sure. However, her failure to register in time to make any meaningful disclosure before the election should not be a basis for not pursuing this inquiry. I urge the Commission to impose appropriate sanctions for the violation of applicable disclaimer rules, and to investigate the possibility that this candidate deliberately delayed registration for more than fifteen days after raising or spending \$5000 in pursuit of her candidacy in order to evade public disclosure obligations.

I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge, information, and belief.

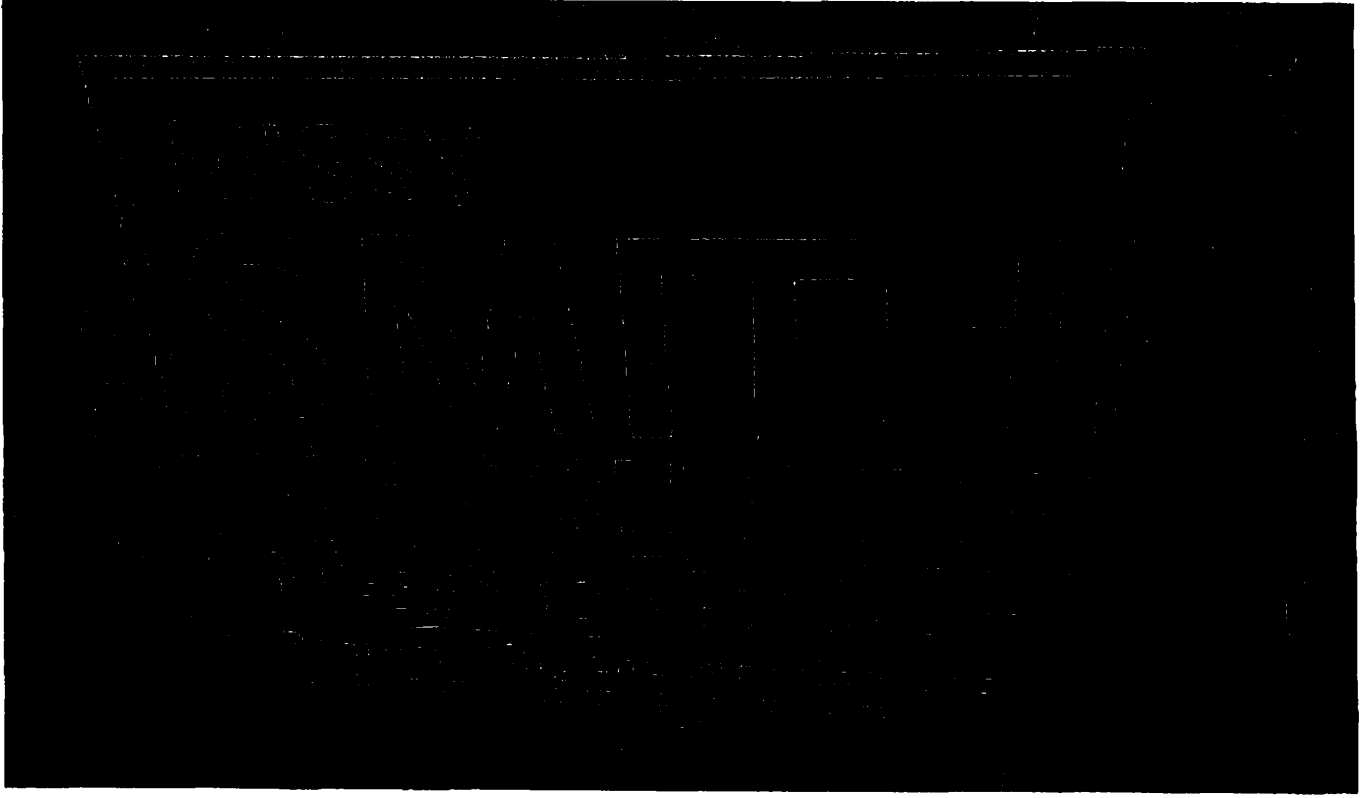

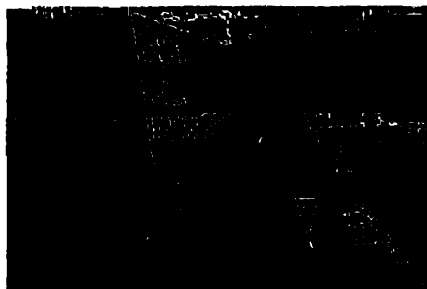

Republican Missy Smith challenges Eleanor Holmes Norton on "baby killing" platform

Missy Reilly Smith is used to preaching her politics from the street. Smith, 67, is a longtime fixture outside District abortion clinics, where she spends mornings as a "sidewalk counselor," urging patients not to abort. Today, Smith prepares to launch her anti-abortion battle on a grander scale: She's running unopposed in the Republican race to challenge Eleanor Holmes Norton's Congressional seat come November.

Smith supports "traditional marriage," chastity, school choice, and "life from conception to the moment of natural death"; she opposes "the selling of baby body parts like they're automobile parts."

She describes herself as "an underdog" in this race.

Smith knows that D.C.'s Republican population resides in the single digits. She understands that Norton commands a significant "war chest." She describes herself as the "first serious candidate to oppose the pro-abortion, big government, liberal incumbent in 20 years."

But she believes that D.C.'s Democrats will heed their moral obligations to vote for Smith. "Traditionally, the Democratic Party was the party of the working man and the working class. But it was perverted and now it's the party of death," Smith says. "I believe there are still many good people that are Democrats and believe in the values that I'm espousing. I believe they will come forward and they will vote for me. But we'll see what God has in store."

God willing, Smith would use her office to achieve two chief policy goals: "reversing the same-sex marriage status that Norton pushed through without any consideration for the citizens of the District of Columbia" and "immediately reversing the federal funding of child killing that is completely evil and contrary to God's wishes."

In order to do so, Smith plans to focus her campaign on the District's black residents, whom she says are "more receptive to my message." Explains Smith: "Wards 7 and 8 are very much against same-sex marriage. And the black family, they are the ones that are being targeted by abortionists. They're deliberately focused on getting rid of the blacks."

Smith, who says she was "pressured into having an abortion" in 1971, went on to found "pre-born" advocacy group "Women Against the Killing and Exploitation of Unprotected Persons," create pro-life radio program "Chastity the New Sexual Revolution," and head up the D.C. chapter of abortion survivor organization "Operation Outcry." Smith also has some experience in the House; last November, she was arrested for protesting the health care bill outside of Nancy Pelosi's office.

Over the next two months, Smith says she plans to roll out an "unprecedented campaign strategy" in order to win over a District that traditionally leans heavily toward the "party of death" (this strategy involves television commercials). Smith will likely be successful in convincing District voters of one thing: "I know no hidden agenda," she says. "I'm pretty up-front about this stuff."

Co-founded St. Anne's Helpers for Life to finance and support women in crisis pregnancies long term. Started a chastity program called "Chastity Programs International" when she realized that the foundation of the pro life movement was the return to the virtues of chastity and purity. Has a radio show on National Pro Life Radio called "Chastity the New Sexual Revolution" for over ten years that interviews the pro life heroes across the nation.
