Subject: 2010 Mississippi Congressional General Election

As you know, on November 2, 2010, the State of Mississippi, along with the other states, will conduct its General Election to choose Representatives for the 112<sup>th</sup> Congress. During the course of the campaign season, a number of violations have occurred.

The Republican challenger in the Second Congressional District race, Bill Marcy, is actively campaigning and raising funds. In the cities of Jackson, Mississippi, and Greenville, Mississippi, he has placed large billboards promoting his candidacy. These advertisements have been displayed on a continuing basis for at least four weeks. Also, at least one advertisement has been placed in a local newspaper (*The Carthaginian*) supporting Mr. Marcy. These advertisements lack the disclaimer required by 11 CFR 110.11(c)(2)(i), (ii) and (iii).

The costs associated with an extended billboard rental in the State's largest media market would trigger the candidate's FEC registration and reporting requirements by 11 CFR 100.3(a) and 102.13(a)(2). Despite months of active campaigning, including travel to various events, design, production and distribution of campaign literature, and billboard placement, Mr. Marcy has not filed any required reports.

Additionally, Mr. Marcy is operating a website ([www.billmarcyforcongress.com](http://www.billmarcyforcongress.com)) and possibly another ([www.byebye Bennie.com](http://www.byebye Bennie.com)), although the lack of filed reports makes it impossible to determine how much it cost and to whom the fees were paid. He lists two campaign offices.

The candidate has failed to disclose any lease payments associated with these two offices.

The above-detailed actions violate the letter and spirit of our campaign finance and election laws. I trust that a prompt and full investigation into these charges is forthcoming. If additional information is needed, please contact me.

## 'Shot across the bow'

### Marcy going after Thompson — in lights

**GREENVILLE** — Republican congressional candidate Bill Marcy has thrown another shot directed at incumbent Rep. Bennie Thompson (D). This time, he's doing it in lights — literally.

Marcy's campaign has rented space on an illuminated billboard in front of Okana Shoe Store Inc., 1891 Dr. Martin Luther King Blvd. S., calling out Thompson's stance on abortion. Marcy wants to replace Thompson as Mississippi's 2nd District Congressional Representative.

"This is a shot directly across the bow of Congressman Thompson," said Marcy, who, with supporters watched the billboard unveiling Tuesday afternoon. "I want him to see this. I want the Delta to see this."

The billboard, which rotates with other advertisements, says: "Congressman Thompson, why do you continue to support abortion?"

The second sign reads: "Since 1973, over 52 million babies have been aborted, 13.8 million have been African American..." citing the Guttmacher Institute as its source.

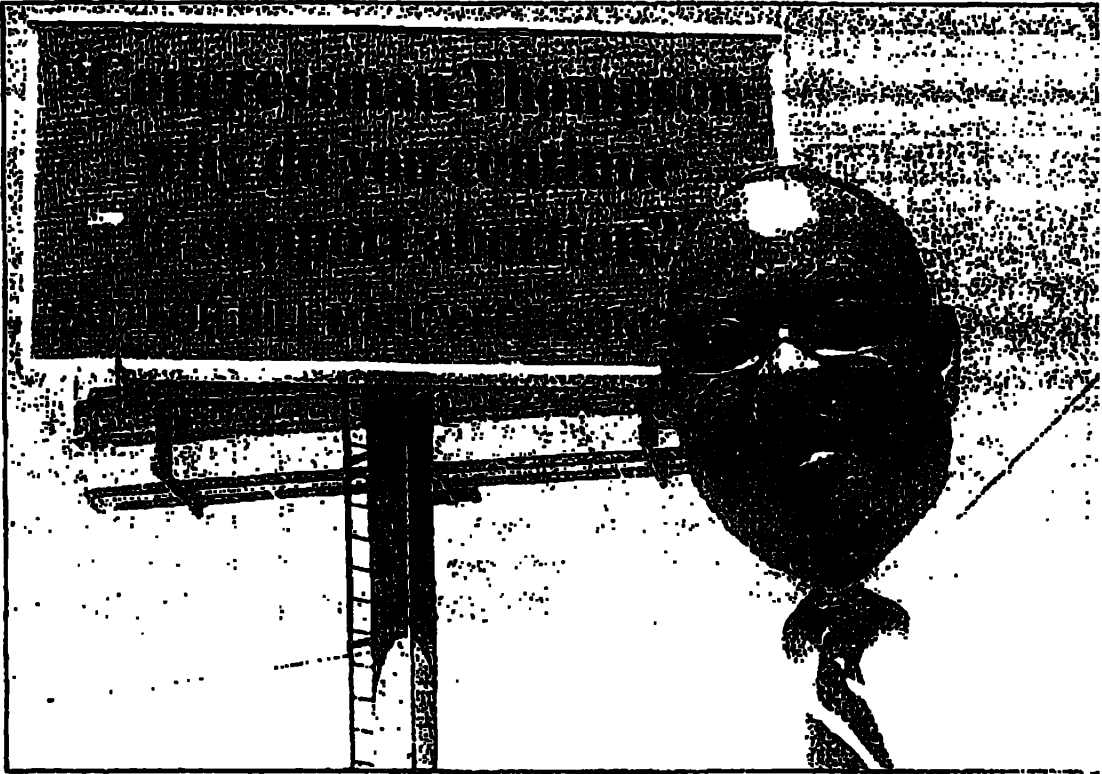
The Guttmacher Institute was founded in 1968 as the Center for Family Planning Program Development.

It became an independent, not-for-profit corporation in 1977 and maintains offices in New York and Washington. The Guttmacher Institute advances sexual and reproductive health worldwide through an interrelated program of social science

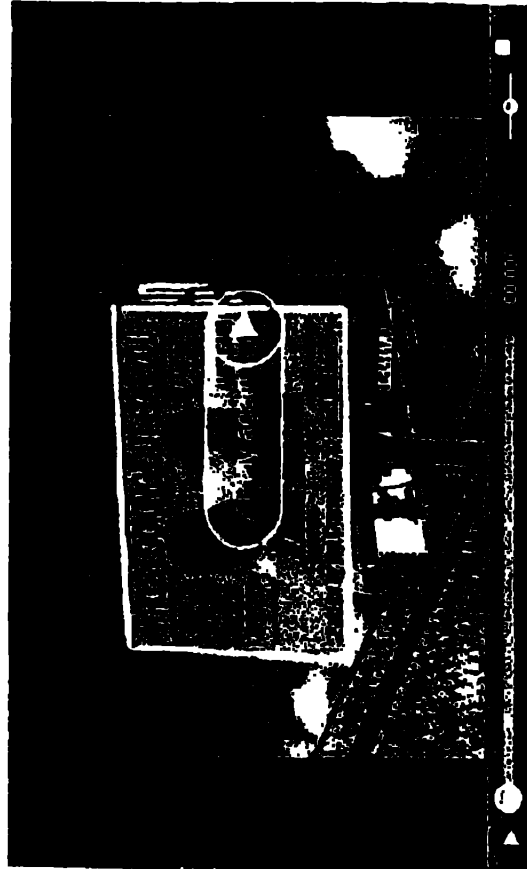

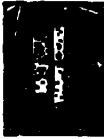
