Dear Mr. Jordan:

In response to your letter dated October 27, 2010, the Governor Heineman Committee (the "Committee") writes to request that the Federal Election Commission (the "FEC") take no action with respect to the complaint filed against the Committee. The Committee, on September 30, 2010, was informally contacted by the Nebraska Accountability and Disclosure Commission (the "NADC") regarding the possibility that a contributor to the Committee may not be a domestic entity. On that same day, the Committee reviewed the facts surrounding the multiple addresses of the contributor, returned the contribution to the local representative of the contributor via hand delivery, informed the NADC of the actions of the Committee, and committed to demonstrate the return of the contribution on the supplemental schedule to the public contribution and expenditure report of the Committee for the reporting period ended September 28, 2010.

Note that the contribution was drawn on a bank located in the United States, that the contributor maintains an Omaha, Nebraska address, and that the form concerning the contribution that was filed by the contributor demonstrates the Omaha, Nebraska address. The Committee understands that the contributor stated publicly its belief that the contribution is not inconsistent with the FEC rules.

Attached for your review is a copy of the September 30, 2010 letter on behalf of the Committee to the NADC, an excerpt from the NADC filing of the Committee for the period ended September 28, 2010, a copy of the contributor-filed contribution reporting form, a copy of the contribution check, and a copy of the contribution refund check.

Based upon the foregoing, the Committee believes that any potential violation of the FEC provisions was inadvertent and that any such violation was corrected in a prompt and transparent fashion. As a result, the Committee requests that the FEC take no further action with respect to this matter.
