Near the close of the 2010 Congressional campaign in the Fifth District of Virginia, I received three mailers that did not identify who authorized or paid for their distribution.

It is my understanding that this is a violation of federal campaign regulations. I would hereby like to make a formal complaint and I ask that this matter be investigated and the issuer of these mailers be penalized according to proper procedures.

The FEC representative I spoke with on November 1, 2010, instructed me to write this letter, have it notarized, and mail it to the FEC with a photocopy of the mailers.
