Dear Ms. Duncan,

Please accept this letter as a complaint against Phillip L. Liberatore, Liberatore for Congress Committee (C00474114), and Kimberly Lepins of Yucaipa, CA for operating in violation of federal campaign election law.

More specifically, the candidate and his committee have violated FEC regulations by accepting an illegal \$150,000 personal loan from a supporter; and Ms. Lepins for giving a federal candidate a \$150,000 contribution.

Here is a timeline of my concerns:

June 6, 2010: Liberatore for Congress Committee accepts a \$150,000 personal loan from candidate, Phillip L. Liberatore. (See 6/7/10 48 House Notice; Attached).

July 16, 2010: On second quarter FEC filing, the name of the \$150,000 loan provider has been changed to "Kimberly Lepins - [Personal Funds]" of Yucaipa, CA. (See July 15 Quarterly Report; Attached).

October 15, 2010: On third quarter FEC filing, shows source of loan as personal funds from Kimberly Lepins of Yucaipa, CA. (See October 15 Quarterly Report; Attached).

January 31, 2011: On fourth quarter FEC filing, shows source of loan as personal funds from Kimberly Lepins of Yucaipa, CA. (See January 31 Quarterly Report; Attached).

I believe the Phillip L. Liberatore and Liberatore for Congress Committee committed two illegal actions:

1. Falsifying FEC documents to hide original source of \$150,000 loan granted on June 6, 2010.
2. Accepting a zero percent interest \$150,000 loan from a contributor in gross violation of federal law.

It is my belief that Phillip L. Liberatore, Liberatore for Congress Committee, and Kimberly Lepins have violated FEC guidelines. Accordingly, I respectfully request that

the commission conduct an immediate investigation into the violations outlined above and impose the maximum penalty under the law.

The foregoing is correct and accurate to the best of my knowledge, information and belief.


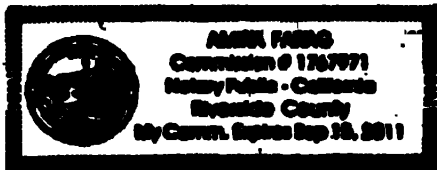
