The Massachusetts Democratic Party would like to file formal complaints against Mr. Sean Bielat, former candidate for United States Congress in the Massachusetts 4<sup>th</sup> Congressional district, and The ABIOMED, INC., a corporation located in Danvers, MA, for their failure to comply with FEC regulations.

On October 21, 2010, The ABIOMED, INC. contributed the maximum amount permitted in a given cycle, \$2,400, to Friends of Sean Bielat, the house political committee of the aforementioned Mr. Bielat. It is a violation of FEC regulations for corporations to donate funds directly to individual political committees.

Given the significant amount of this donation and the serious nature of this violation, The Massachusetts Democratic Party urges the Federal Election Commission open an immediate investigation into the illegal campaign contribution from The ABIOMED, Inc. to Friends of Sean Bielat.

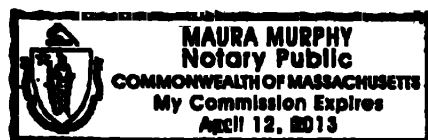
Attached to this complaint is the filing from the Friends of Sean Bielat political committee showing the illegal contribution of \$2,400 from The ABIOMED, Inc.

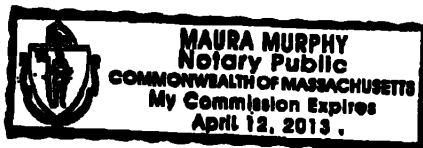
