The complaint in MUR 6481 was received by the respondents listed above on Tuesday, July 19, 2011. As you know, 11 C.F.R. § 111.6(a) provides that a respondent may file a written response to a complaint within fifteen (15) days of receiving it. Since the above-named respondents received the complaint on July 19, 2011, a response is due next Wednesday, August 3, 2011.

Although I have initiated an investigation into the allegations of the complaint, there will not be sufficient time to complete that effort and file a written response on behalf of the above-named respondents by next Wednesday. In order to prepare a complete response, I will need to interview a number of witnesses who may have direct knowledge of the events alleged to have occurred in the complaint. Accordingly, I hereby request an extension of time of thirty (30) days until Friday, September 2, 2011 in order to file a response to the complaint in MUR 6481 on behalf of the above-named respondents.
