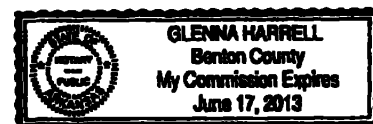
Earlier this summer, Representative Womack agreed to attend a fundraiser, held on June 28, 2011 for the Arkansas House Leadership Political Action Committee, a nonfederal, state political action committee. Neither Representative Womack, nor any agent or staff member of Representative Womack, agreed to raise any funds in conjunction with the event, and at no time did Representative Womack or any of his agents or staffers ask for any money to be contributed in conjunction with the event. Representative Womack solely agreed to attend the fundraiser. Unbeknownst to Representative Womack, the Arkansas House Leadership Political Action Committee sent out an invitation which stated that Representative Womack was a host of the fundraiser. We learned about Representative Womack's inclusion on the invitation on July 13, 2011. Despite the fact that Representative Womack did not raise any funds associated with the fundraiser, we immediately asked the Arkansas House Leadership Political Action Committee to refund all of the money raised from the event, and they have agreed. We understand that Federal candidates may not serve as a host for a nonfederal fundraiser, and though Representative Womack was listed as such on an invitation, he certainly did not raise any nonfederal funds in conjunction with the event.

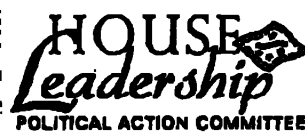
