III. BACKGROUND:

Other Violations of the Federal Election Campaign Act: Cash on Hand Discrepancy and Unauthorized Disbursement of Committee Funds

A committee representative of Lynch for Congress ("the Committee") contacted the Reports Analysis Division (RAD) to report the Committee's possible cash on hand discrepancies totaling approximately \$81,100.00 and possible unauthorized use of campaign funds totaling approximately \$3,100.00.

On March 8, 2010, a representative of Lynch for Congress ("the Committee") contacted the Reports Analysis Division (RAD) Analyst in regard to a Request for Additional Information (RFAI) referencing the 2010 12-Day Pre-Special Primary Report covering October 1, 2009 through January 13, 2010 (Image 10030250974). The Committee representative indicated that they were going to respond to the RFAI. The Committee representative also stated that the Committee may have been improperly using campaign funds and provided examples of campaign funds disbursed for the apparent personal use of the candidate, Edward J. Lynch ("the Candidate"), over the 2009-2010 election cycle. In addition, the Committee representative provided data regarding possible misreporting of the Committee's cash on hand beginning in March 2008 through 2010.

To Whom It May Concern:

I would like to start by reiterated that according to our conversation my name will not be disclosed during this investigation. Secondly, be aware that Mr. Lynch carries a gun and has made no qualms about using it. Also as of the date of this letter, Mr. Lynch may attempt to create missing invoices and receipts.

Section 2:7 Treasurer's Duties

The treasurer (or registered assistant treasurer) is responsible for:

Filing complete and accurate reports and statements on time. 104.14(d).

Signing all reports and statements. 102.2(a) and 104.14(a).

Depositing receipts in the committee's designated bank within 10 days of receipt. 103.3(a).

Authorizing expenditures or appointing an agent (either orally or in writing) to authorize expenditures. 102.7(c).

Monitoring contributions to ensure • compliance with the law's limits and prohibitions. 103.3(b); 110.1(k)(3). Keeping the required records of receipts • and disbursements for three years from the date of the report to which they relate. 102.9(c) and 104.14(b).

Section 2:9 Campaign Depository

A committee must list the name and address (but not the account number) of the campaign depositories it maintains for depositing receipts and making disbursements. 102.2(a)(1)(vi). (One depository is required, although others may be designated as well.) All committee disbursements must be made by check or similar drafts drawn on a designated campaign depository. 103.3(a).

Open cases against Lynch for Congress and fines going back to 2008

AF1932; AF 1880: AF1896- still not paid as of the 3/9/2010- According to the letters Mr. Lynch received the fines must be paid in 30 days- is this a violation? With the following information and the fact that they are open cases and the fact that letters Mr. Lynch received states he will be audited (which he stated he never will be and can't), and that he continues to use the account for personal use, Mr. Lynch should be audited as soon as possible.

1. According to the FEC filing Q1 period ending 3/31/2008 Mr. Lynch loaned the campaign \$29,800.00 of his own money and deposited into the Suntrust bank account . There are no bank statements for March thru June 2008
2. According to the FEC filing Q2 period ending 6/30/2008 Mr. Lynch loaned the campaign \$50,000.00 of his own money and deposited into the Suntrust bank account . There are no bank statements for March thru June 2008
3. 2 Suntrust accounts closed on/about November 2008 and opened on/about 9/1/2008

4. Bank statement dated 8/31/2009 funds were paid for personal bills Planet Fitness gym membership, doctor's visit, drivers license
5. Bank statement dated 9/30/2009 funds were paid for personal bills gun holster, gym membership, car parts, music store
6. Bank statement (no official statement) dated 10/31/2009 funds were paid for personal bills Planet Fitness gym membership, pass for turnpike, note that checks were written for cash by Mr. Lynch with no receipts or designation for what it was for. On the FEC filing, Mr. Lynch reflected the checks as reimbursement of loans he made to the campaign.
7. Bank statement dated 11/30/2009 funds were paid for personal bills Planet Fitness gym membership, note that checks were written for cash by Mr. Lynch with no receipts or designation for what it was for. On the FEC filing, Mr. Lynch reflected the checks as reimbursement of loans he made to the campaign.
8. Bank statement dated 12/31/2009 funds were paid for personal bills Planet Fitness gym membership, Build a Bear Workshop, Florida Power and Light (FPL) \$1718.00 account the account # for our office location account paid with a check # 1076, note that checks were written for cash by Mr. Lynch with no receipts or designation for what it was for. On the FEC filing, Mr. Lynch reflected the checks as reimbursement of loans he made to the campaign. Also Mr. Lynch sold a Jeep Wrangler for \$14,000.00 which was deposited into Lynch for Congress, Inc. and Mr. Lynch withdrew \$9000.00. I believe the IRS has an open case against Mr. Lynch or Delon who may be looking for these funds.
9. Bank statement dated 1/31/2010 funds were paid for personal bills Planet Fitness gym membership.
10. Bank statement dated 2/28/2010 funds were paid for personal bills Planet Fitness gym membership, BMX Radio. Mr. Lynch continued to pay FPL for his home out of this account. Note Mr. Lynch withdrew \$1050.00 with no receipts or designation for what it was for.

NOTES

1. There are few receipts for items purchased by Mr. Lynch using the check card
2. Mr. Lynch's loans do not agree with his repayments
3. Mr. Lynch used this account for his personal use. Lunch was purchased almost every day for Mr. Lynch and the campaign manager. In accordance with the IRS guidelines only a portion of entertaining can be considered a write off
4. Mr. Lynch did use his home office for the campaign office but it was a approximately 10x14 office in 2008 and 2009. If Mr. Lynch was entitled to reimbursement of use of this office he never requested it in 2008 or 2009.
