I have received a letter from your office regarding my client Timothy Karp. I enclose a copy of a designation of counsel form signed by Mr. Karp.

The paperwork associated with getting reimbursed by the company all clearly describes the conduct and supports the conclusion that the parties involved were unaware of the fact that such conduct was violative of the law.

Since these events, Mr. Karp has sought legal counsel and is aware of the legal requirements. He is also cooperating fully with all investigators. We would welcome a conciliation process in this matter.
