Dear Ms. Matthews:

On April 18, 2011, the Federal Election Commission notified the 2006 Committee to Elect Cynthia Rodriguez Matthews to 26th Congressional District and you, individually and in your capacity as treasurer, that it had ascertained information in the normal course of carrying out its supervisory responsibilities indicating that the Committee and you, individually and in your official capacity as treasurer, may have violated the Federal Election Campaign Act of 1971, as amended (the "Act"). Information setting forth the factual basis for the allegations was provided to you and the Committee at that time. After a review of the information, the Commission on December 13, 2011, found that there is reason to believe the 2006 Committee to Elect Cynthia Rodriguez Matthews to 26th Congressional District and you in your official capacity as treasurer violated 2 U.S.C. § 434(a) and (b), provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"), reason to believe you violated 2 U.S.C. § 432(e)(1), a provision of the Act, and instituted an investigation. A notification of the Commission's findings, accompanied by the Factual and Legal Analysis forming a basis for the Commission findings, was forwarded to you and the Committee at that time. This letter is to advise you and the Committee that this matter is under review by the Commission, and we expect the Commission will next vote on this matter in February 2013. After the Commission votes, you and the Committee will receive notification of the Commission's determination.


This matter will remain confidential in accordance with 2 U.S.C. §§ 437g(a)(4)(B) and 437g(a)(12)(A), unless you and the Committee notify the Commission in writing that you wish the investigation to be made public. Please note that you and the Committee have a legal obligation to preserve all documents, records and materials relating to this matter until such time as you are notified that the Commission has closed its file in this matter. See 18 U.S.C. § 1519.
