RESPONSE AND MOTION TO DISMISS COMPLAINT

Respondent Friends of Christine O'Donnell, Matt Moran in his official capacity as Treasurer of the Committee¹ ("Treasurer"), ("Respondent"), files this Response to the Complaint filed with the Federal Election Commission ("Commission") by Jonathon Moseley ("Moseley") claiming that Respondent has violated the Federal Election Campaign Act of 1971, as amended ("the Act"). Respondent affirmatively states that neither the Committee nor its Treasurer have committed any violation of the Act and moves the Commission to dismiss the Complaint.

Response to Allegations of Complaint

FACTS OF THE COMPLAINT

Moseley has alleged that because he accepted a settlement of amounts he claimed to be owed from his work with Christine O'Donnell's unsuccessful 2008 campaign for the United States Senate from Delaware, that somehow his settlement of those amounts almost *two years ago* now constitutes a violation of the Act. His claims are frivolous, without merit and false. The Complaint is frivolous, without merit and false – and should be dismissed.

Jonathon Moseley was a volunteer in Christine's O'Donnell's 2008 unsuccessful campaign for the U.S. Senate in Delaware. According to a statement from Moseley on September 3, 2010, "...as campaign manager for Christine's 2008 primary campaign, I would have been the highest paid campaign employee in her primary. Yet Christine's campaign never owed me for my work because we never agreed on a salary. I happily volunteered."

Also according to Moseley's statement, "All expenses I submitted have now been completely retired. The campaign no longer owes anything on those expenses. Moseley clarified that his statement is his own at his expense, and has not been coordinated with the O'Donnell campaign." See Attachment #1.

In addition, on June 29, 2010, then Treasurer of the Friends of Christine O'Donnell committee, Sandle Taylor, sent a letter to Moseley with a check in the amount of \$700.00 as full and complete payment of any amounts claimed to be owed by Respondent to Moseley, with notice that by cashing the enclosed check, you (Moseley) was indicating that he agreed to the payment of \$700 as full and complete payment in full of any/all amounts owed by Respondent to Moseley. See Exhibit A, Attached to Complaint.

Moseley indeed cashed the check on or after June 29, 2010, issued his public statement on September 3, 2010 stating that "All expenses I submitted have now been completely retired. The campaign no longer owes anything on those expenses."

Moseley has attached to his complaint an invoice that ostensibly represents amounts due and owing to him as of June 2, 2008 in the amount of \$5,758.55. See Attachment D to Moseley Complaint. However, it must be noted that the so-called 'invoice' is addressed to Christine O'Donnell at 518 North Lincoln Street, Herndon, VA 20171, and *not* to Respondent, Friends of Christine O'Donnell, PO Box 3987, Wilmington, DC 19807, the address of the campaign.

Moseley certainly knew the address of the campaign: On April 25, 2008, Moseley filed a Statement of Organization for Friends of Christine O'Donnell as its Treasurer. See Amended Statement of Organization (4/25/2008), Attachment #2. The address of the campaign committee is Wilmington, Delaware and *not* in Herndon, Virginia. Neither the Respondent nor Christine O'Donnell were located in Herndon, Virginia at any time.

In July, 2008, Moseley resigned as Treasurer of the Committee and notified the Commission that he had been replaced as Treasurer and "Furthermore, the campaign has also not shared with me most of the financial information that I would need to file the required FEC reports." See Notice to the Commission filed on July 1, 2008.

According to Respondent's FEC filings, the amount(s) claimed by Moseley were first reported to the Commission in the Respondent's Pre-Primary 2008 Report. The amount reported as being claimed by Moseley was \$4,000 and the memo entry indicated that the amount was "Under Review". See July 2008 Quarterly Report (7/15/2008), Attachment # 3 which reflects no amounts owed to Moseley. See Respondent's 2008 Pre-Primary Report (8/27/2008), Attachment #4, which reflects an amount of \$4,000 being reviewed by Respondent.

Moseley was paid \$2000 on August 22, 2008 and another \$700 on September 26, 2008, leaving a balance due and reported of \$1300. See October 2008 Quarterly Report (10/15/2008), Attachment #5.

From and after October, 2008, the following FEC reports were filed reflecting that Moseley was owed \$1300 by Respondent: See 2008 Pre-General Report (10/23/2008), Attachment #6; 2008 Post-General Report (12/08/2008), Attachment #7; 2008 Year End Report (01/29/2008), Attachment #8; April 2009 Quarterly Report (04/14/2009), Attachment #9; July & October 2009 Quarterly Reports / 2009 Year End (01/24/2010), Attachment #10; Amended July 2009 Quarterly Report (04/15/2011), Attachment #11; Amended October 2009

Quarterly Report (04/15/2011), Attachment #12; April 2010 Quarterly Report (04/15/2010), Attachment #13

A check for \$700 was written and sent to Moseley on June 29, 2010 with the notice that acceptance of the payment would be deemed full and final settlement of any amounts owed. The check had not been cleared through Respondent's bank account by the end of the reporting period on June 30, 2010. Accordingly, the July 2010 Quarterly Report reflected a payment of \$700 and an outstanding balance of \$600 due to Moseley. See Attachment #14.

Once Moseley deposited the check for \$700, in accordance with the settlement letter that accompanied the check, Respondent deemed all amounts owed to Moseley to have been paid in full. The 2010 Pre-Primary Report filed in August 2010 thus reflected a reduction of the remaining \$600 and reported no further amounts owed to Moseley. See Attachment #15.

Moseley issued his public statement in September 2010 confirming that he had been fully paid all amounts owed to him by Respondent. See Attachment #1.

At no time during the two years in which Respondent reported to the FEC that the amount owing Moseley was \$1300 did he ever indicate that the amount(s) he claimed to be owed were in excess of that amount. At no time did Respondent receive the 'invoice' addressed to Christine O'Donnell at the Herndon, Virginia address.

Within the past year, Moseley has become increasingly obsessed with and about Christine O'Donnell, demanding additional payments for work not performed and claiming moneys are due to him which are not. To finally resolve the situation, Respondent's Delaware attorney filed an action in civil court in Delaware to bring to an end the threats, attacks and unmerited claims asserted by Moseley against Respondent and Ms. O'Donnell. See Exhibit B, attached to Moseley complaint.

Commission regulations authorize campaign committees to resolve amounts unpaid to individuals for expenses and/or salary related to campaigns. See 11 C.F.R. §§116.5 and 116.6.

Moseley has made a number of contradictory statements regarding the amount(s) he claims are 'owed' to him by Respondent: for two years he never challenged the amount of \$1300 as the amount owed to him and reported as such by Respondent, yet he now claims the amount was substantially more than \$1300.

Moseley accepted \$700 in full satisfaction of the amounts owed and was on notice that the payment of \$700 was settlement if the check was accepted and negotiated, which it was. He then publicly stated that he was owed nothing from Respondent and that he was a 'volunteer' during the 2008 campaign, yet he now claims he is owed \$5,058.55.

Respondent has no record of receipt of the 'invoice' Moseley claims was submitted to Christine O'Donnell at an address in Herndon, Virginia – nor is there any documentation to substantiate the expenses and amounts referenced in the 'spreadsheets' attached to the Complaint.

Moseley has a history of making false statements and was suspended from the practice of law by the Virginia Bar Association for misconduct. See Attachment #16, Public Record of Disciplinary Action by Virginia State Bar Association against Jonathan Moseley. *Virginia State Bar ex rel Seventh District Committee v. Jonathan Alden Moseley*, CL 52390, VSB Docket No. 05-070-1200.

In summary, the Complaint is false, baseless, frivolous, without merit and is part of an ongoing campaign being waged by Moseley to attack, harass and stalk Christine O'Donnell, and is filed by an individual with a history of making false and frivolous claims.

The Complaint should be dismissed with no further action by the Commission.

MEDIA ADVISORY, Sept. 3 /Christian Newswire/ -- Christine O'Donnell may be poised to repeat in Delaware's Senate primary on September 14 the surprise upset in Alaska of the tea party candidate over Senator Murkowski. National talk show host Mark Levin has endorsed Christine O'Donnell and The Tea Party Express is spending \$250,000 for campaign ads in a very small State.

Christine's concerns about my spending was one reason I did not continue with her 2008 campaign. It is wrong to blame Christine for my actions. I was confident that beating Joe Biden would motivate conservative donors nationwide. Christine wanted to be more conservative with her 2008 campaign finances."

"Meanwhile, as campaign manager for Christine's 2008 primary campaign, I would have been the highest paid campaign employee in her primary. Yet Christine's campaign never owed me for my work because we never agreed on a salary. I happily volunteered. Absolutely, I hoped donors in Delaware and nationwide would step up to oppose Senator Biden and the campaign would show appreciation for my work if it were flush with cash. But Christine's campaign never owed me for my work, because I was never supposed to be paid if funds were not abundant."

Moseley concluded: "All expenses I submitted have now been completely retired. The campaign no longer owes anything on those expenses."

Moseley clarified that his statement is his own at his expense, and has not been coordinated with the O'Donnell campaign.

MEMORANDUM OPINION AND ORDER

THIS MATTER came before the Three Judge Panel consisting of the Honorable Marcus D. Williams, Chief Judge Designate, the Honorable Thomas A. Fortkort, Retired, and the Honorable John E. Kloch, Retired, presiding on March 16-18, 2009 for purposes of determining whether Respondent engaged in Misconduct. The Respondent, Jonathan A. Moseley appeared in person pursuant to a duly noticed Rule to Show Cause dated November 14, 2008 appointing the time and place for the hearing. Respondent was represented by counsel, Daniel M. Gray, Esquire who noted his appearance. The Virginia State Bar was represented by Assistant Bar Counsel, Paulo E. Franco, Jr.; and it

FURTHER APPEARING that the Court swore in the Court Reporter and the parties presented opening statements and the Bar put on its case in chief and then rested. The Court then heard oral argument on the Respondent's Motion to Strike and after having considered argument overruled the Motion to Strike; and it

FURTHER APPEARING that the Respondent put on his case in chief and then rested; and it

FURTHER APPEARING that the Respondent then moved to strike the Bar's case after having rested his case in chief and the Court, after having considered argument, overruled the Motion to Strike; and it

FURTHER APPEARING that after having heard closing arguments of counsel the Three Judge Panel retired to deliberate on the Charges of Misconduct and after having duly deliberated on the matter announced its findings in open court on March 18, 2009 and made the following findings of fact and conclusions of law:

1. The charges relating to Virginia Rule of Professional Conduct 1.7 (a)(1), (a)(2), (b)(3) and (b)(4) are dismissed as the Court finds that Respondent had a reasonable belief that he could continue representing Mr. Ammons and that Mr. Ammons had waived any conflict after consultation with other counsel;
2. The charge relating to Rule 3.1 is dismissed as the Court finds no clear and convincing evidence that Mr. Ammons' claim against the Christian Coalition of America, Inc. was totally frivolous;
3. The charge relating to Rule 3.4(a) is dismissed as the Court finds that there was no clear and convincing evidence that Respondent sought to obstruct access to evidence;
4. The charge relating to Rule 3.4(i) is dismissed as the Court finds that there was no clear and convincing evidence that Respondent presented threats of criminal charges solely to obtain advantage in a civil case;
5. The charge relating to Rule 3.7(a) is dismissed, the Court finding no violation of that Rule, and further finding that dismissing Respondent from the Ammons litigation would

have worked an undue hardship on Mr. Ammons and that it was unclear from the evidence that Respondent would have been called as a witness in the case;

6. The Court finds that the Bar has proven by clear and convincing evidence that Respondent violated Rule 3.3(a)(1) given the circumstances of the Ammons litigation leading up to the July 15, 2004 hearing, as set forth in the transcripts (VSB Exs. 6-8) and orders (VSB Exs. 4 and 5) that the Bar introduced into evidence, that the Respondent had a duty to disclose to the court in a timely fashion that he and his client had found a copy of the contract that they alleged formed the basis for the claim against the Christian Coalition of America, Inc.

7. The Court further finds that the Bar has proven by clear and convincing evidence that Respondent violated Rule 3.3(a) (1) in that he made a false statement of fact to the American Arbitration Association, as set forth in his letter of November 9, 2005, a part of the Bar's Exhibit No. 17, concerning Judge Alper's Order of November 23, 2004 (VSB Ex. 9);

8. The Court finds that the Bar has proven by clear and convincing evidence that Respondent violated Rule 3.4(e) in that the Court concludes that the Respondent filed frivolous discovery requests in the first Ammons case as supported by the transcripts (VSB Exs. 6-8) and orders (VSB Exs. 4 and 5) and as supported by examples of the frivolous discovery requests received into evidence (VSB Exs. 23, 24, 28, 29 and 32);

9. The Court finds that the Bar has proven by clear and convincing evidence that Respondent violated Rule 3.4(j) in that the Court concludes that Respondent filed suit, asserted positions and took other action on behalf of his client when it was obvious that such action would serve only to harass or maliciously injure another as supported by the transcripts and orders (VSB Exs. 5, 8, 11 and 14);

10. The Court finds that the Bar has proven by clear and convincing evidence that

Respondent violated Rule 4.1(a), the Court concluding that Respondent did in fact author the email dated March 3, 2006 which the Arlington County Circuit Court received into evidence on March 16, 2006 (VSB Ex. 131). The Court finds that the email (VSB 131) contains knowingly false statements about Judge Alper, and the Court further finds its conclusion that Respondent authored VSB 131 is supported by Respondent's statements and representations in prior proceedings, including but not limited to his statements under oath in a lawsuit he filed in the United States District Court for the Eastern District of Virginia (VSB Ex. 135), documents and testimony received by this Court during the hearing of this case, as well as Respondent's own testimony in this case.

11. The Court further finds that the Bar has proven by clear and convincing evidence that Respondent violated Rule 4.1(a) in that he knowingly made a false statement of fact concerning Judge Alper's Order of November 23, 2004 (VSB Ex. 9) to the American Arbitration Association, as set forth in his letter of November 9, 2005, a part of the Bar's Exhibit No. 17;

12. The Court finds that the Bar has proven by clear and convincing evidence that Respondent violated Rule 8.2 in that he made false statements concerning the qualifications or integrity of Judge Alper as set forth in the email Respondent authored dated March 3, 2006, which the Arlington County Circuit Court received into evidence on March 16, 2006 (VSB Ex. 131). The Court's conclusion that Respondent authored the March 3, 2006 email contained in VSB 131 is supported by Respondent's statements and representations in prior proceedings, including but not limited to his statements filed under oath in a lawsuit he filed in the United States District Court for the Eastern District of Virginia (VSB Ex. 135), documents and testimony received by this Court during the hearing of this case, as well as Respondent's own testimony in this case.

13. The Court finds that the Bar has proven by clear and convincing evidence that Respondent violated Rules 8.4(a), (b) and (c) based upon the Court's review of the transcripts and orders (VSB Exs. 3-9, 11 and 14), the testimony and other exhibits received into evidence at the trial of this hearing, and the Court further concludes that the totality of the foregoing Rule violations in paragraphs 1-12 herein constitute violations of Rules 8.4(a), (b) and (c); and it

FURTHER APPEARING that the Respondent, having previously been found in violation of the Rules of Professional Conduct, the parties were ordered to and did appear before the Three Judge Panel on June 1, 2009 for the purposes of determining an appropriate sanction; and it

FURTHER APPEARING that the Respondent did appear in person and that the Bar was represented by Paulo E. Franco, Jr., Assistant Bar Counsel; and it

FURTHER APPEARING that the Court swore in the Court Reporter, granted Respondent's leave to represent himself *pro se* and to discharge his attorney, Daniel M. Gray; and it

FURTHER APPEARING that the Court reviewed Respondent's Motion to Vacate and Petition For Writ of Error Coram Nobis and denied the same in open court and directed the parties to present their evidence, Respondent proceeding first; and it

FURTHER APPEARING that at the conclusion of the evidence during the sanctions phase of this proceeding the Respondent and the Bar presented closing arguments, as reflected in the transcripts of the proceedings, and that the Three Judge Panel retired to deliberate; and it

FURTHER APPEARING that having deliberated the matter, and making a specific finding that the sanction it was imposing was based strictly on the evidence of Misconduct as set forth in the Three Judge Panel's Interim Order of Misconduct entered on April 20, 2009, and

recognizing that Respondent had no prior disciplinary record, had already been sanctioned in the Arlington County Circuit Court and recognizing the egregiousness of Respondent's Misconduct in the Arlington County Circuit Court, the Three Judge Panel hereby

ORDERS that the Respondent's license to practice law in the Commonwealth of Virginia be and the same is hereby **SUSPENDED FOR A PERIOD OF SIX (6) MONTHS** effective June 15, 2009; and it is

FURTHER ORDERED that the Respondent shall comply with the requirements of Paragraph 13-29 of Part Six, Section IV, Paragraph 13 of the Rules of the Supreme Court of Virginia ("Rules"); and it is

FURTHER ORDERED that the Clerk of the Disciplinary System shall comply with all requirements of the Rules, including but not limited to complying with the public notice requirements of Paragraph 13-9.G. of the Rules; and it is

FURTHER ORDERED that the Clerk of the Disciplinary System of the Virginia State Bar shall assess all costs against the Respondent pursuant to Paragraph 13-9.E of the Rules.

FURTHER ORDERED that the Clerk of the Loudoun County Circuit Court shall mail a copy teste of this Order by certified mail, return receipt requested, to the Respondent, Jonathon Alden Moseley, at his last address of record with the Virginia State Bar, 4386 Harbortown Circle, Southport, NC 28461 and to 4956-14 Long Beach Road SE #311, Southport, NC 28461, the address that Respondent lists on his pleadings.
