Re: "Obama-Biden 2012"

Dear Mr. Smith and Mr. Herman:

We are counsel to Obama for America ("the Committee"). It has recently come to our attention that someone is soliciting and collecting contributions through direct mail and over the Internet by fraudulently presenting itself as an organization acting on behalf of the Committee.

In a direct mail piece, a sample of which is attached hereto, the organization asks people to "work for Obama-Biden reelection." It solicits contributions and instructs people to make checks payable to "Obama-Biden 2012." The Committee has never received any contribution from, nor has it had any involvement or other association with, "Obama-Biden 2012."

The direct mail piece also invites people to visit a website with the address: <http://obama-biden2012.org>. The Committee did not establish, does not own, and did not authorize this website. The website has misappropriated the Committee's website logo and merchandise. It includes a bank statement for an account named "Obama-Biden 2012." As in the direct mail piece, the website solicits contributions and asks people to "Donate Now."

A WHOIS search of the site <http://obama-biden2012.org> reveals that the website's registrant is:



It also appears that an entity named Exodo 80, a non-profit corporation registered in Florida, may be playing a role in this activity. In the publicly available corporate records, Miguel Figueroa is listed as the registered agent and President of Exodo 80.

"Obama-Biden 2012" is fraudulently misrepresenting itself as acting on behalf of the Committee for the purpose of soliciting contributions. See 2 U.S. C. § 441h(b). We respectfully request that you undertake an immediate investigation of this matter, and promptly take steps to seek appropriate judicial relief to prevent future harm to our client.



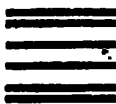
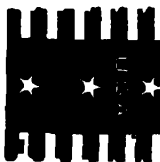
