In researching the Republican candidates seeking to represent Oklahoma House District 2, one campaign distinguishes itself by appearing to violate three distinct policies of the Federal Election Commission (FEC).

By use of public communication, it is my understanding that the campaign of Markwayne Mullin, otherwise known as "Mullin for Congress" has violated policy by using the personal plumbing business of Markwayne Mullin to promote his candidacy.

In both print and video advertising, the campaign uses storefront images, logo-bearing Mullin plumbing vehicles, and business employees to promote the candidate. Examples would be the enclosed mailer and the following link to the campaign website <http://www.mullinforcongress.com/>.

A second contention is the issue of receipts for donations amounting to greater than the allowed \$2500 per election. As per the FEC website, the Mullin campaign has made numerous redesignations and reattributions of donations. This is an excessive number, especially when compared to the other candidates. This indicates a consistent pattern of flouting the policy, to be addressed only if caught.

The matter in which the redesignations were made are also questionable. Some of the parties involved operate as corporations in the State of Oklahoma. An unusual amount of donations are being accepted from businesses, which then are redesignated as being received from separate individuals.

Also at issue are reports showing the campaign accepts more than one donation from an individual which total \$10,000 or more. This is in violation of policy indicating that donations should be given in increments not to exceed \$2,500 per election. Even if redistributed to allocate \$2,500 each for the general, primary, and runoff elections, this amount would still be only \$7,500.

Because the above violations occur numerous times, it indicates to me an unethical pattern of allowing such contributions, rather than a single infraction which was then corrected.

The third issue is that there are a number of direct violations according to the FEC rules prohibiting corporations from making donations directly to a campaign.

Attached is a copy of the corporation status for just a few of the businesses listed on the FEC report.

It is also my understanding that the F.E.C. has requested additional proof on a few of the contributions mentioned above.

I believe the unusual methods being used by the campaign and pattern of questionable donations give reason for concern and have therefore prompted my complaint.

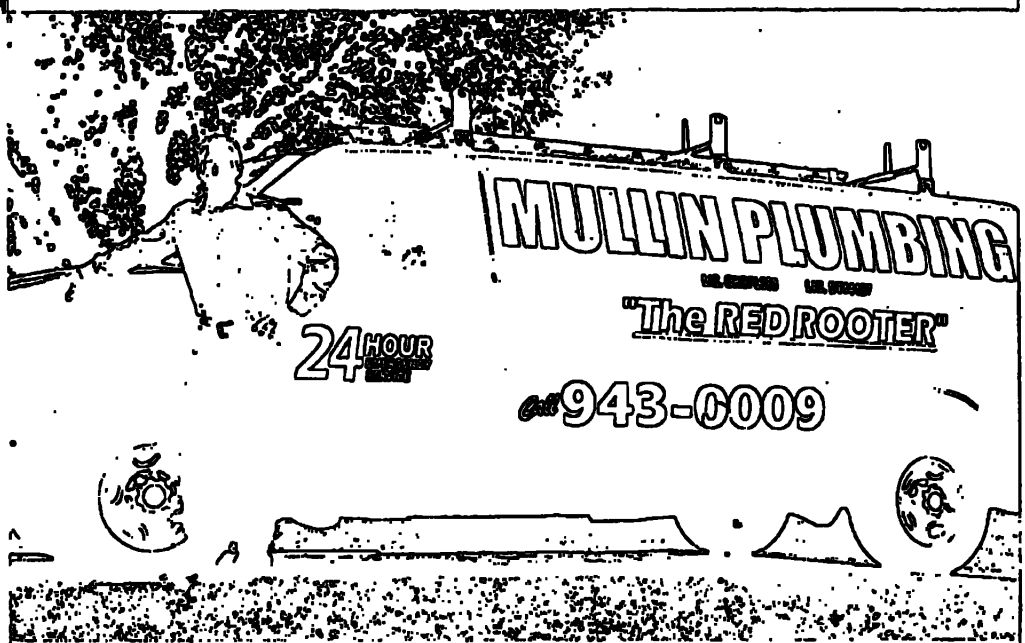



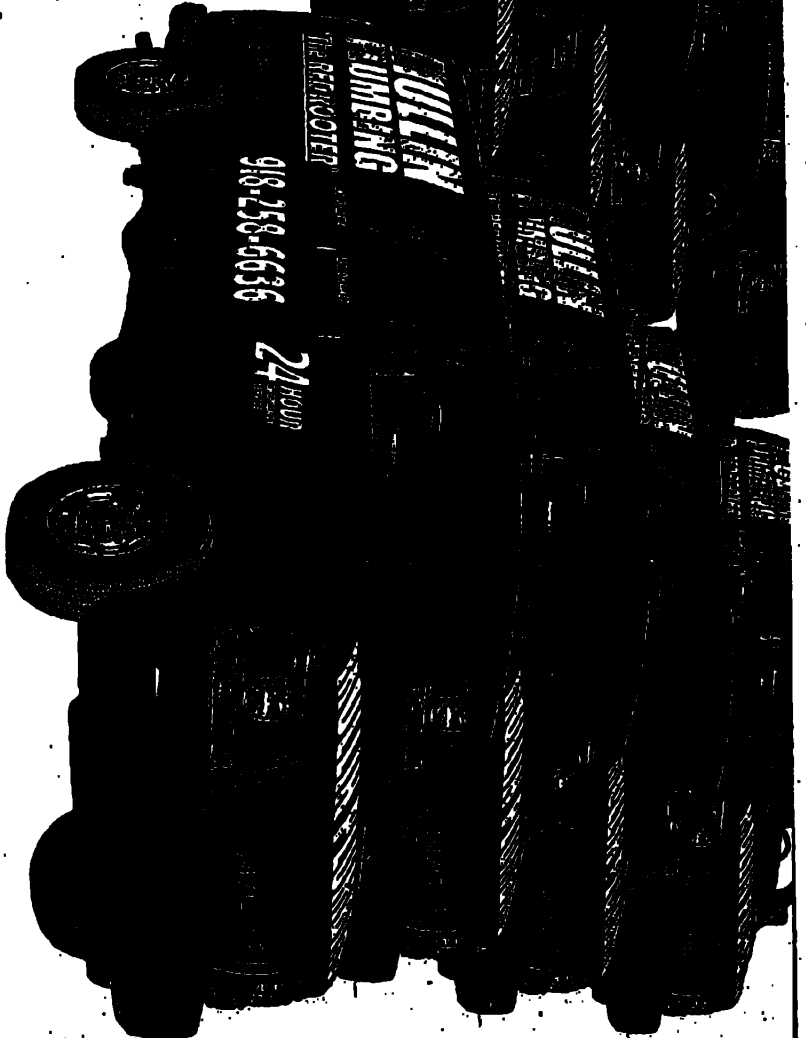
