Dear Sir or Madam:

I represent Jerry Reed and RECO Enterprises (hereinafter "Respondent"), and Reco Electric Co., in response to the FEC's MUR 6542 correspondence, pursuant to the enclosed Statement of Designation of Counsel. Jerry Reed is the sole owner of both RECO Enterprises and Reco Electric Co. *Please note*, although the FEC letter appears to be stamped March 30, 2012, the correspondence was received by Respondent on June 4, 2012.

After reviewing the documents enclosed with the FEC's letter, and after careful review of 2 USC Ch. 14, Federal Election Campaigns, I find absolutely no violation of any provision of the Federal Election Campaign Act of 1971 as indicated by the FEC. Consequently, no action should or can be taken against Reco Electric Co. by the FEC.

Review of the enclosed documents will show that on June 29, 2011, RECO Enterprises (not Reco Electric Co.) wrote check number 033762 in the sum of \$2,500.00 to Mullins For Congress. Subsequently, on June 29, 2011, Mullins For Congress wrote check number 1003 back to RECO Enterprises in the sum of \$2,500.00, which was deposited into the RECO Enterprises account on July 15, 2011. Subsequently, on June 29, 2011, Jerry Reed, owner of RECO Enterprises, wrote check number 1146 to Mullins For Congress in the sum of \$2,500.00, which was deposited by Mullins For Congress on July 15, 2011.

Therefore, it is clear that no contribution was made by Reco Electric Co. to Mullins For Congress, and the only contribution made by Respondent was a personal check to Mullins For Congress by Jerry Reed.

Upon your review please contact me with any further questions, and please confirm that no action will be taken against Reco Electric Co.
