COMPLAINT

Friends of Weiner violated the Federal Election Campaign Act by filing numerous public disclosure reports with the Federal Election Commission that have not disclosed more than \$68,000 in outstanding debt owed to a vendor for compliance services provided to Friends of Weiner in connection with two FEC audits of the committee.

1. This complaint is filed with the Federal Election Commission ("FEC") in accordance with the provisions of 2 U.S.C. §437g(a)(1) in the belief that Friends of Weiner ("Weiner") violated the Federal Election Campaign Act of 1971, as amended, 2 U.S.C. §§431 et seq. (the "Act") and related FEC regulations, 11 C.F.R. §§100.1 et. seq.
2. Political committees are required to file accurate reports disclosing outstanding debts owed pursuant to 2 U.S.C. §434(b)(8) and 11 C.F.R. §104.3(d).
3. Debts and obligations owed by a political committee which remain outstanding must be continuously reported until extinguished. 11 C.F.R. §104.11(a).
4. Political committees are even required to continuously report disputed debts if the creditor has provided something of value to the committee. Until the dispute is resolved, the political committee is required to disclose on reports any amounts paid to the creditor, any amount the political committee admits it owes, and the amount the creditor claims is owed. 11 C.F.R. §116.10(a).
5. Beginning in 2003 and continuing through today, Weiner has not disclosed on its FEC reports \$15,258.75 in outstanding debt owed to Whitney Burns ("Compliance Consultant") for 404.50 hours of compliance services provided in connection with the audit of Weiner for the 1999-2000 election cycle (the "First FEC Audit").

a. In 2001, 2002, and 2003, Whitney Burns provided 404.5 hours of FEC compliance services to Weiner in connection with the First FEC Audit. These services included:

- (1) Review and reconcile bank statements; review contributor records and data; balance and organize contributions by deposits; identify potential excessive contributions pursuant to FEC regulations; prepare letters and documentation to verify joint attributions and election designations; reconcile disbursements and review backup documentation; organize and prepare physical records for audit; and discussions with Weiner treasurer in preparation for audit field work.
- (2) Review issues with FEC audit staff during fieldwork; respond to questions; review compliance issues with Weiner's attorney and treasurer; and prepare response to FEC audit staff "Exit Conference" findings concerning the disclosure of contributions, disbursements, 48 hour notices, and financial information.
- (3) Prepare comprehensive amendments to 1999-2000 FEC reports in response to FEC Interim Audit Report from information compiled and verified during audit preparation and field work.
- (4) Periodic review with the Weiner treasurer and staff concerning on-going FEC requests for additional information on 2001-2002 FEC reports.

b. A copy of Compliance Consultant's September 2, 2003 invoice sent to Weiner for \$15,258.75 for services provided in connection with the First FEC Audit is attached as Exhibit 1.

c. Compliance Consultant has not received any payments from Weiner for the First FEC Audit services.

d. Weiner has not reported any outstanding debt owed to Compliance Consultant on its FEC reports covering the period September 2003 through January 2011. A copy of Weiner's FEC report summary pages for this time period are attached as Exhibit 2.

e. Weiner's failure to disclose the outstanding debt owed to Compliance Consultant is a violation of 2 U.S.C. §434(b)(8), 11 C.F.R. §§104.3(d), 104.11(a). If Weiner now claims that the debt is disputed, then it is still a violation of 11 C.F.R. §116.10(a) for failure to disclose a disputed debt.

6. Beginning in 2009 and continuing through today, Weiner has not disclosed on its FEC reports an additional \$53,077.50 in outstanding debt owed to Compliance Consultant for 529.50 hours of

services provided in connection with the audit of Weiner for the 2003-2004 election cycle (the "Second FEC Audit").

a. In 2005, 2006, 2007, 2008, and 2009, Compliance Consultant provided 529.50 hours of FEC compliance services to Weiner in connection with the Second FEC Audit. These services included:

- (1) Reconcile bank statements; trace account transfers; reconcile brokerage account calculating net gains/losses, earned interest, dividends, and brokerage fees; review income tax returns for consistency; update reporting data; prepare financial schedules supporting FEC report amendments; review allocation issues; prepare and file comprehensive amendments to reports updating summary cycle to date and cash on hand figures; periodic review with treasurer and staff concerning on-going FEC audit staff requests; prepare response to FEC Exit Conference; prepare response to additional findings (including New York City mayoral campaign allocation issues); prepare response to FEC's Interim Audit Report; prepare special response to Final Audit Report; edit final campaign response to FEC; and review all work with Weiner's attorneys and accountants.
- (2) Review contributor records and data; reconcile contribution data by check and credit card deposit; identify prohibited and excessive contributions pursuant to FEC regulations; prepare letters and documentation to verify permissibility of contributions; recommend refunds; develop charts tracing contribution re-attributions and re-designations; prepare schedule of unitemized contributions; prepare schedule of mis-deposits (New York City mayoral campaign); update committee name and address data; and review contribution issues with FEC audit staff.
- (3) Review disbursements records and physical documentation; prepare physical records for FEC audit; and research on vendor accounts including the location of supporting invoices, statements, and specific transactions identified by the FEC audit staff.

b. A copy of Compliance Consultant's August 21, 2009 invoice sent to Weiner for \$53,077.50 for services provided in connection with the Second FEC Audit is attached as Exhibit 3.

c. Compliance Consultant has not received any payments from Weiner for Second FEC Audit services provided to the committee.

d. Weiner has not reported any outstanding debt owed to Compliance Consultant on its FEC reports covering the period August 12, 2009 through January 2011. See Exhibit 2.

e. Weiner's failure to disclose the outstanding debt owed to Compliance Consultant is a violation of 2 U.S.C. §434(b)(8), 11 C.F.R. §§104.3(d), 104.11(a). If Weiner now claims that the debt is disputed, then it is still a violation of 11 C.F.R. §116.10(a) for failure to disclose a disputed debt.

7. Compliance Consultant made repeated attempts over the years to collect the debt owed by Weiner. Compliance Consultant had numerous conversations with Weiner staff about the outstanding debt. Compliance Consultant hesitated from filing a complaint with the Commission or to sue the campaign because he was a Member of Congress and I was concerned that taking such action would damage my business.
8. After Anthony Weiner resigned from Congress, Compliance Consultant made further attempts to collect more than \$68,000 in debt that Weiner owed before he attempted to terminate his campaign committee. On June 17, 2011, Compliance Consultant sent a certified letter to Nelson Braff, the Weiner treasurer, with copies of invoices requesting payment. A copy of the June 2011 letter and the U.S. Postal Service certified letter receipt showing that Mr. Braff received the letter are attached as Exhibit 4.
9. Weiner did not disclose the outstanding debt owed to Compliance Consultant on the FEC report filed on July 15, 2011 even though the committee and treasurer knew of the debt it owed.
10. On January 27, 2012, Compliance Consultant notified the individual who prepared Weiner's 2011 Year End Report of the amount owed by Weiner.
11. Weiner did not disclose the outstanding debt owed to Compliance Consultant on the FEC report filed on January 31, 2012 even though the committee was informed of the debt it owed.

#### **Conclusion**

Weiner has not disclosed more than \$68,000 in outstanding debt owed to Compliance Consultant for services performed for the committee in connection with two FEC audits in violation of 2 U.S.C. §434(b)(8), 11 C.F.R. §104.3(d), §104.11(a), and possibly §116.10(a).

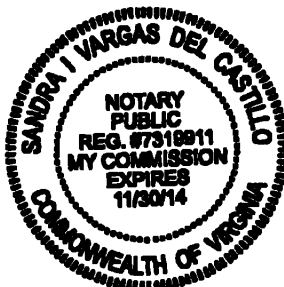
