I would like to file a complaint about Dick Muri. He states he is running for the 10th Congressional District in Washington State, but your online records reflect he is running in the 9th.

Dick Muri ran for the 9th Congressional District in 2010 against Adam Smith and lost. He has been running against Adam Smith ever since then. He has had fund raisers, sent out letters and e-mails all saying he was running against an incumbent in December 2011.

The Tacoma News Tribune (major newspaper) printed a press release from Dick Muri on December 28, 2011 saying he was running for the new 10th Congressional District.

I looked up his FEC report this morning and it says he is running for the 9th.

There is no new Statement of Candidacy, and certainly not within the required time frame by the FEC.

His Amended Year End Report was submitted April 3, 2012 — 93 days after his public announcement (in the major newspaper of the area, The Tacoma News Tribune) of changing districts. I was told by the FEC that he had 15 days to file a new Statement of Candidacy and another 15 days change his committee.

As of this morning, April 9th, there is still no new Statement of Candidacy filed. Also, his amended year end report dated April 3rd, certainly puts him very much out of compliance with FEC rules.

Dick Muri has raised about \$100,000 over the past year running for the 9th Congressional District. Will he be able to transfer those donations without asking contributors? What do contributors do if they are not supporting Mr. Muri for the new district?

Is this a situation that Dick Muri will get away with, not following the rules? Are there penalties?

This is most certainly a blatant disregard for FEC procedures.

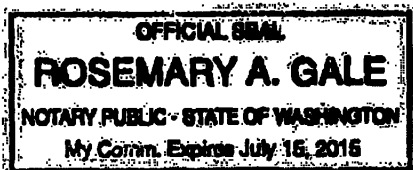
