RE: Complaint Against California 8th Congressional District Candidate Angela Valles and the Angela Valles for Congress Committee, FEC ID# C00504217

Dear Mr. Herman:

I, Irmalinda Tapia, submit this complaint of unlawful federal election activity against California 8th Congressional District candidate Angela Valles and the Angela Valles for Congress Committee, FEC # C00504217, pursuant to section 111.4 of the Commission's regulations.

On May 9, 2012, candidate Angela Valles and the Angela Valles for Congress Committee, FEC #C00504217 (VALLES), began broadcasting radio advertisements over FCC-regulated radio stations in the state of California. (see link for audio from internet publicity authorized by VALLES)

Under provisions of the Federal Election Campaign Act of 1971, 2 U.S.C. § 431, Section 311, the "Stand By Your Ad Provision" of the Bipartisan Campaign Reform Act of 2002, all candidates and federal candidate-controlled committees are required by United States law to publicly state that they implicitly authorize or approve the content of any and all radio and television advertisements on behalf of the campaign.

A review of the aforementioned advertisement paid for by VALLES and currently being broadcast on California radio contains no such language as required by federal law under the Federal Election Campaign Act of 1971, 2 U.S.C. Section 431, subsection 311. I request that the Federal Election Commission immediately open an investigation to determine if a violation occurred and, if so, to take all appropriate steps to remedy that violation of federal law.



OPTIONAL INFORMATION

INSTRUCTIONS FOR COMPLETING THIS FORM

The wording of all Jurats completed in California after January 1, 2008 must be in the form as set forth within this Jurat. There are no exceptions. If a Jurat to be completed does not follow this form, the notary must correct the verbiage by using a jurat stamp containing the correct wording or attaching a separate jurat form such as this one which does contain proper wording. In addition, the notary must require an oath or affirmation from the document signer regarding the truthfulness of the contents of the document. The document must be signed AFTER the oath or affirmation. If the document was previously signed, it must be re-signed in front of the notary public during the jurat process.

- State and County information must be the State and County where the document signer(s) personally appeared before the notary public.
- Date of notarization must be the date that the signer(s) personally appeared which must also be the same date the jurat process is completed.
- Print the name(s) of document signer(s) who personally appear at the time of notarization.
- Signature of the notary public must match the signature on file with the office of the county clerk.
- The notary seal impression must be clear and photographically reproducible. Impression must not cover text or lines. If seal impression smudges, re-seal if a sufficient area permits, otherwise complete a different jurat form.
 - ♦ Additional information is not required but could help to ensure this jurat is not misused or attached to a different document.
 - ♦ Indicate title or type of attached document, number of pages and date.
- Securely attach this document to the signed document
